EXECUTIVE SUMMARY:

In June 2009, Council adopted the goal of conducting a "senior needs assessment through collaboration with the Senior Advisory Commission and non-profit agencies." In collaboration with the Senior Advisory Commission and local non-profit and senior-serving public agencies, the Parks & Recreation Department developed a 40 question survey tool. The survey studied eight areas of need: Health & Nutrition; Social Engagement; Finances; Support/Activities; Safety; Housing; Communication; and, Transportation & Access. In 2010, the survey was widely promoted through the City's Website, channel 15, flyers, emails, e-Notify and Tweets. Over two dozen locations were visited by volunteers and staff to solicit senior participation including: senior residential facilities, City libraries, fraternal and service organizations, farmer's market, citywide special events, and the Santa Clara Senior Center.

In 2011, data from 2,087 unduplicated responses were analyzed with assistance from the Department of Psychology at Santa Clara University. While not a "scientific random sample survey," the assessment provides statistically valid results from which reasonable conclusions can be drawn. Santa Clara seniors consist of three distinct age subgroups: the "Young-Old" 50-64 years of age (15.5%, or 18,052 people); the "Middle-Old" 64-79 years of age (6.9%, or 8,036 people); and, the "Oldest-Old" 80+ years of age (3.1%, or 3,610 people). The Young Old are the largest growing subgroup within the older adult population and have different characteristics from the others. The Young-Old are more likely to work, be financially secure, be better educated, less likely to need assistance with daily living, and less likely to have a chronic health condition. The reverse is true for the Oldest-Old. The survey results are being used by staff to better understand the distinct needs of these three senior sub-groups and to modify programs where appropriate to better serve each sub group. The work with the senior serving community agencies has also been beneficial for ongoing communication, planning and coordination of services.

From April through October 2012, the Senior Advisory Commission reviewed the Senior Needs Assessment results and recommended that Council accept the report findings and further consider the Commission's recommendations in future policy and program decisions that affect seniors. A copy of the final report is in the Council Offices for review. Staff recommends that Council note and file the report.

ADVANTAGES AND DISADVANTAGES OF ISSUE:

The Senior Needs Assessment Report provides statistical data and information to help understand the needs of Santa Clara seniors in the eight areas of study: Health & Nutrition; Social Engagement; Finances; Support/Activities; Safety; Housing; Communication; and, Transportation & Access. The three distinct age subgroups the "Young-Old" 50-64 years of age; the "Middle-Old" 64-79 years of age; and, the "Oldest-Old" further provide insights into there different needs. While the size and scope of the study was limited due to funding constraints, the research can potentially inform future program and policy considerations.

ECONOMIC/FISCAL IMPACT:

There is no economic or fiscal impact in accepting the survey report. Understanding the distinct needs of the three senior sub-groups and modifing City programs, where appropriate to better serve each sub group, can be accomplished within the current budget. The collaborative work with other senior serving community agencies to better plan and coordinate services also has no additional cost. Any additional or new programs developed to meet needs identified in the survey would have additional operating costs and need to be brought forward and evaluated in the context of the annual budget process.

Further analysis of the survey results would incur costs for research personnel and data sampling.

RECOMMENDATION:

That the Council note and file the Senior Needs Assessment final report.





PART ONE: EXECUTIVE SUMMARY

In June 2009, the Santa Clara City Council adopted a goal of assessing the needs of Santa Clara seniors in collaboration with the Senior Advisory Commission and non-profit agencies. In 2010, a survey tool was developed by the City Parks & Recreation Department in collaboration with senior service agencies. The 40 survey questions covered eight key topics or areas in the lives of seniors: Health and Nutrition; Social Engagement; Finances; Support/Activities; Safety; Housing: Communication; and, Transportation and Access. There were 2,087 surveys returned and reviewed. Data from 1,987 unduplicated respondents was able to be tabulated and included in the results. Santa Clara seniors consist of three distinct age subgroups, in academic terminology: the "Young-Old;" the "Middle-Old;" and, the "Oldest-Old." According to the 2010 U.S. Census, 25.5% of Santa Clara's 116.468 residents are over the age of 50, or about 30,000 people. The Young-Old seniors constitute 15.5% of Santa Clara's population, or 18,052 people. The Middle-Old seniors make up 6.9% of Santa Clara's population, or 8,036 people. The Oldest-Old seniors comprise 3.1% of Santa Clara's population, or 3,610 people. The 2010 City of Santa Clara Senior Needs Assessment provides a comprehensive look at how seniors see themselves and how well their needs are met at a particular point in time. The survey results indicate that each group of seniors is diverse and has unique needs, not easily categorized by a single description. This report summarizes the survey results and may assist the City in future decision making and opportunities to improve the lives of Santa Clara residents. Further research can provide additional clarity to the findings of this survey.



PART TWO: INTRODUCTION

2.1 Goal

In June 2009, the Santa Clara City Council adopted the goal of conducting a "senior needs assessment through collaboration with the Senior Advisory Commission and non-profit agencies" in keeping with the City's value of being service-oriented and communicative. The survey would provide the Council with information about the needs of Santa Clara seniors, age 50 and older. The Parks and Recreation Department began working on the project in September 2009¹, completed the survey in 2010, and analyzed the survey data in 2011. The survey was completed "in-house" with existing staff and volunteers to minimize project cost.

2.2 Methodology

City staff met and consulted with a volunteer "working group"² of professionals invited from local agencies that serve Santa Clara seniors to assist in the development of an assessment tool. The working group members³ met several times⁴ to review comparable survey tools and various methodologies, as well as the last senior survey conducted by the City of Santa Clara in 1999⁵.

While many areas could have been studied, the working collaborative developed eight topical areas of focus for the 2010 survey⁶:

1. Health and Nutrition

- 4. Support/Activities
- 5. Safety
- 6. Housing
- 7. Communication
- 8. Transportation and Access

The collaborative members were invited to develop and submit sample questions in the areas of focus that were either of specific interest to their agency or applicable to seniors in general. This collaborative approach enabled both a diversity of personal and professional perspectives to be included and an ability to later correlate the answers from the City survey to other outside agency's information. Questions were reviewed by the collaborative and survey questions of interest to more than one agency were ranked higher in value for inclusion. Consideration was also given to the length, design and format of the survey.

Prior to distributing the survey to the public, it was reviewed by the Parks and Recreation Department, the Senior Advisory Commission, collaborative working group members, the City Manager's Office and two focus groups comprised of Senior Center participants. To encourage a higher return rate, return postage was paid by the City of Santa Clara.

2.3 Scope of Survey

A 40-question survey was mailed to every business and residence by the City of Santa Clara Parks and Recreation Department. A total of 50,000 surveys were mailed as an insert in the June 2010 issue of *Inside Santa Clara*. An electronic version of the survey was available on the City's website. Efforts to promote broad participation in the survey included: advertisements on cable television channel 15, promotional flyers at Parks and Recreation Department

facilities, postings on the City's website, emails sent to participants in Parks and Recreation department programs, as well as the City's e-Notify and Twitter.

More than two dozen sites in the City of Santa Clara were visited by volunteers and staff to solicit participation in the survey, including: senior residential facilities, City libraries, fraternal and service organizations, farmer's market at the Kaiser Permanente Medical Center- Santa Clara campus, the City of Santa Clara July 4th All City Picnic, and the Santa Clara Senior Center.

The deadline for respondents to return the survey was July 9, 2010. Upon receipt, surveys were divided into three groups: those returned in U.S. mail by the deadline (1,588), those completed online by the deadline (356), and those returned in U.S. mail after the deadline (143). A total of 2,087 surveys were returned and reviewed. Of those returned, 1,989 unduplicated respondents were able to be tabulated and included in the results. The rate of return for the Senior Needs Assessment was four percent; the typical rate of return for survey research is between one and two percent. While the assessment was not a "scientific random sample survey," the assessment does provide statistically valid results from which reasonable conclusions can be drawn.

Upon return, the survey data was entered into a Microsoft Excel spreadsheet by volunteers from the Santa Clara Senior Center, Heart of the Valley, Santa Clara University, Santa Clara High School, and Wilcox High School. Data collected from surveys completed online were incorporated into the spreadsheet by the City's Web Manager. The data was analyzed by Patti Simone, Ph.D., Associate Professor in the Department of Psychology at Santa Clara University and Lindsey Sanchez, Graduate Assistant. A full analysis of the data and correlations exceeded the scope of the project and the limited resources available for conducting the senior needs assessment.

PART THREE: FINDINGS

3.1 Survey Demographics

According to the 2010 U.S. Census, the City of Santa Clara has 116,468 residents.⁷ Of these, 25.5% are over the age of 50. In order to understand the characteristics and potential needs within this large age range, researchers and academicians divide this group into three subgroups:

- the Young Old (50-64);
- . the Middle-Old (64-79); and,
- the Oldest-Old (80+).

Within the City of Santa Clara, the Young Old constitute 15.5% of the over 50 population or 18,052 people. The Middle-Old make up 6.9% of Santa Clara's population or 8,036 people. The Oldest-Old comprise 3.1% of Santa Clara's population or 3,610 people. The Senior Needs Assessment data mirrors the population data for the United States which shows that the Young Old are the largest growing subgroup within the older adult population and have different characteristics from the others. As the survey data illustrates, the Young-Old have different needs than seniors in the two older subgroups. The Young-Old are more likely to work, be financially secure, be better educated, less likely to need assistance with daily living, and less likely to have a chronic health condition. The reverse is true for the Oldest-Old. The tables and graphs on the following pages provide a visual representation of the survey questions and results, beginning with a demographic overview of the survey respondents, followed by the eight areas of



focus for the Senior Needs Assessment: Health and Nutrition; Social; Finances; Support/Activities; Safety; Housing; Communication; Transportation and Access. The report provides a summary of the data. Additional data analysis may help develop correlations and greater clarity on the topic areas surveyed.

It is important to note that the total number of responses for each question varies and may be more or less than the number of surveys returned and analyzed; this is due to not all respondents answering every question, or portion of a question; some questions had opportunities for multiple answers, such as "choose all that apply;" and, some of the tables and graphs provide depictions of the correlations among two or more questions. For consistency, charts use a similar color for each of the senior sub-groups. Miscoded answers and blanks are not included in the final results.

Age.⁹ The age range of survey respondents is from 50 to 104 years of age. The average age is 72. Santa Clara seniors from all three age subgroups are well represented in the survey responses: 37% of the responses were from the Young-Old (50-64 years of age); 40% the Middle-Old (64-79 years); and, 23% the Oldest-Old (80+ years).

Gender. Sixty percent of respondents are female; fourty percent are male. The survey has a balanced distribution of responses for each gender and age group.



Sexual orientation. 11 Ninety-six percent of respondents reported being heterosexual, while 4% reported being homosexual or bisexual.


ZIP Code. 12 Respondents living in each Santa Clara ZIP Code were represented as follows: 53% live in 95051, 40% live in 95050, and 7% live in 95054. The graph also indicates the number of respondents in each age from each ZIP code. Over 50 respondents in each age group were surveyed in each ZIP code except for the Oldest-Old in 95054.

Residency.¹³ The survey indicates that 82 % of Santa Clara seniors have lived in the United States for more than 50 years, 13 % from 26-50 years, and only 5%, 25 years or less. ¹⁴


The survey also indicates that 38% (689) of seniors have lived in Santa Clara for 1-25 years, 45% (833) for 26-50 years, and 17% (306) for more than 50 years. Most Santa Clara seniors



(62%) have lived in the City for at least 26 years.

Education. 15 Overall, 22% of Santa Clara seniors have completed some

graduate school or an advanced degree, 24% have a bachelors degree, 33% have some college, 18% have a high school education level, and 3% have completed less than a high school education. There is some variance among age groups as shown at right.



Language Preference. 16 96% of seniors prefer to receive information in English. Other languages¹⁷ were also indicated. However, the survey was distributed and available only in English.

Senior Center Use. 18 61% of Santa Clara seniors report using the Senior Center. Across the age groups, 58% of the Young-Old; 66% of the Middle-Old; and, 58% of the Oldest-Old


use the Senior Center.

Why seniors don't use the Senior Center.19 The most frequent explanations given for why seniors do not use the Senior Center differ among age groups. 32% of the Young-Old cite the hours



of operation and 31% do not know what is offered. 29% of the Middle-Old report

not knowing what is offered and 26% not being interested in what the Center has to offer. 37% of the Oldest-Old report transportation difficulties as the


primary reason they do not use the Center.

Over all, 18% of seniors are still working, too busy or do not find the hours of operation convenient. 5% report having a disability or physical limitation that limits Senior Center use. 5% perceive themselves as "too young" or "too old" to use the Senior Center.

3.2 Health and Nutrition

The needs assessment attempted to answer how seniors perceived their health and nutrition, areas critical for maintaining the quality of life for seniors.


Comparative Health.²⁰ When asked to rate their health compared to other people their age, 52% of all Santa Clara seniors rate their health as "good," 25% percent as "excellent," 20% as "fair," and 3% rated their health as "poor." Of those reporting "fair" or "poor" health, not surprisingly, it is over 33% of the Oldest-Old, compared with only 19% of Young-Old and 20% of Oldest-Old.


Exercise.²¹ Most seniors in every age group exercise. 85% of Santa Clara's seniors in each age group report exercising on average from several times per

week, to weekly or daily. The percentage of seniors who never exercise increases with age, from 6% of the Young-Old, up to 13% of the Oldest-Old.




Doctor Visits.²² Over all, most Santa Clara seniors (56%) report seeing a doctor several times a year: 48% of Young-Old, 59% of Middle-Old, and 65%

Oldest-Old. It is next most common for seniors to see a physician yearly: about 42% of Young-Old, 29% of Middle-Old, and 22% of Oldest-Old. As



many as 12% of Oldest-Old report seeing their physician monthly, compared with

11% of the Middle-Old, and 8% of the Young-Old. For those who report seeing a physician less than once





per year,²³ across age groups, the most commonly reported reason (63%) is that it is "not needed." However, for the Young-Old group, 54% report that a significant reason for going to a doctor less than once-a-year, is due to "no insurance." Over 14% of the Young-Old and 18% of the Middle-Old report the reason for going to a


doctor less than once a year, is that it is "too expensive."

Major health concerns.²⁴ While 54% of seniors overall report having a major health concern, further



detail reveals that 46% of Young-Old report having a major health concern compared to 55% of the Middle-Old, and 64% of the Oldest-Old. The most

health concerns among all Santa Clara seniors are, in descending order: high blood pressure/heart disease (27%), arthritis (21%), pain (13%), and diabetes (12%).



Mental Health of Seniors.²⁵ Levels of Depression. When asked about their mental health, 59% of all Santa Clara seniors report feeling "not at all" "sad,


depressed, or helpless"
while 62% of the
Young-Old report "not
at all." However, 8%
of all seniors responded
"often" or "always"
feeling "sad, depressed,
or helpless."



Levels of Disinterest. ²⁶ The follow up mental health question confirmed that 62% of all seniors, and 64% of the Young-Old, 64% of the Middle-Old, and 55% of the Oldest-Old report "not at all" feeling disinterested in enjoyable activities. There is an increased disinterest with the Oldest-Old 36% feeling sometimes disinterested.

Levels of Anxiety.²⁷ About 49% of Santa Clara seniors, across age groups, report "not at all" when asked if they feel anxious. Somewhat less (41%) report

"sometimes" when asked if they feel anxious. Very few of any age group responded "often" (9%) or "always" (2%).



Level of Relaxation. ²⁸ The inverse question to "levels of anxiety" measured how relaxed seniors felt. The responses "sometimes" and "often" were reported most frequently, accounting for a combined 76% of all seniors across all three age groups. Including the "always" response results in over 85% of all seniors reported feeling relaxed. 15% of seniors were "not at all" relaxed.

Level of Isolation.²⁹ When asked about feeling isolated 69%, across age groups, reported "not at all," with the least isolated being the Middle-Old at 73%.


Across all age groups, about 23% of seniors reported feeling isolated "sometimes" (slightly higher for the Oldest-Old), and 6% "often" and 2% "always."

Quality of Life.³⁰ Most seniors (82%) rate the quality of their life as "excellent" (26%) or "good" (56%). Conversely, about 2% of Santa Clara seniors report the quality of their life as poor and 17% as "fair." While the Oldest-Old

from fewer
ratings of
"excellent".

Nutrition.³¹ 82% of all Santa Clara seniors do not miss balanced meals, with the Oldest-Old (87%) reporting least missed meals. Conversely, seniors who miss meals, report missing meals "weekly" (9%) more often than "monthly" (4%), or


"daily" (5%). The primary reasons reported by seniors who do report missing balanced meals, are "too much effort"


(17%) and "cost" (7%).



Meals.³² For those seniors who do miss balanced meals, 58% report having eaten at a senior center or other

Congregate meals site. The Young-Old are more likely to use a food bank than a congregate meal-site, whereas the Oldest-Old will second most frequently participate in Meals on Wheels. The majority (80%) of seniors however, report never having used an alternate meal source.








3.3 Social Needs

Over 30% of seniors attend activities, services, or meetings "weekly," 33 while 18% several times per week, 24% attend outside activities



"monthly," and 22% "never." Santa Clara seniors, across age groups, are almost twice as likely to have contact with family and friends³⁴ on a "daily" basis (48%)

as they are on a "weekly"
(23%) or "several times a
week" (19%) basis. Contact
does diminish slightly with
older cohorts. However, only
2% of all seniors report



"never" having contact with friends.





3.4 Senior Employment & Finances.36

The number of seniors who work decreases with increased age from 55% of the Young-Old, 9% of the Middle-Old and less than 1% of the Oldest-Old, while the number of retired seniors increases with each age group, from 17% of Young-Old, to 64% Middle-Old, to 81% of the Oldest-Old. 42% of Young-Old work full-time compared to about 4% of Middle-Old, and less than 1% of the Oldest-Old. The Young-Old are more than twice as likely to be working full-time, working part-time (13%) or looking for work (14%), than they are to be retired (17%). Volunteer work peaks for seniors in the Middle-Old years at 10%.

















Ability to Pay for Needs.⁴¹ The Great Recession had a profound effect on both the economy and the personal finances of the general population. The following areas looked at how Santa Clara's seniors perceive their "ability to pay" for various needs. For the vast majority, it is "very easy" or "somewhat easy" to pay for food, home maintenance & repairs, insurance, mortgage/rent, prescription meds, utilities, and transportation. However, unexpected major expenses are difficult for most seniors.

Food. Across age groups, a little over 85% of seniors' report their ability to pay for food is "somewhat easy" and "very easy" combined, and conversely a little

over 14% "somewhat difficult" and "very difficult" combined. By age group, 85% of the Young-Old, 87% of the Middle-Old, and 86% of the Oldest-Old report it being "somewhat"




and "very easy" to pay for food. Conversely, paying for food is "somewhat" and "very difficult" for 16% of the Young-Old, 13% of the Middle-Old, and about 14% of the Oldest-Old.







Conversely, paying for transportation is "somewhat" and "very difficult" for 22% of the Young-Old, 18% of the Middle-Old, and about 21% of the Oldest-Old.



difficult" combined. By age group, to pay for unexpected major expenses, only 48% of the Young-Old, 52% of the Middle-Old, and 47% of the Oldest-Old report it being "somewhat" and "very easy" combined. Conversely, paying for unexpected major expenses is "somewhat" and "very difficult" for 52% of the Young-Old, 48% of the Middle-Old, and about 53% of the Oldest-Old.


Utilities. Across age groups, about 80% of seniors' report their ability to pay for *utilities* is "somewhat easy" and "very easy" combined, and conversely about 20% "somewhat difficult" and "very difficult" combined. By age group, to pay for *utilities*, only 78% of the Young-Old, 81% of the Middle-Old, and 79% of the Oldest-Old report it being "somewhat" and "very easy" combined. Conversely, paying for *utilities* is "somewhat" and "very difficult" for 21% of the

Young-Old, 18% of the Middle-Old, and about 20% of the Oldest-Old.




3.5 Support/Activities

While overall, 49% of Santa Clara seniors report needing no help with Activities of Daily Living (ADL), a look at each age group separately indicates 69% of the Young-Old, 55% of the Middle Old, and 24% of the Oldest-Old need no assistance; and the Oldest Old are the age group most likely to need help with ADL. While the percent varies by age group, overall what seniors receive help for is: cleaning 23%; transportation 18%, shopping & cooking 12%, laundry11%. The Oldest-Old report needing help with cleaning 12%, transportation 9%,, shopping and cooking 6%.



When assistance is needed, seniors rely upon friends or relatives (42%), Private

pay services (33%), and in hone support services (8%). Seniors report that if they are not currently receiving help that they need help with cleaning, medication,



3.6 Safety


Most Santa Clara seniors report that they feel safe. 42 Across the three ZIP

codes 95050, 95050, and 95054 more than 83% of seniors rate their *personal safety* as "good" or "excellent" combined. More than



79% rate their street lighting levels as "excellent" or "good". More than 70% of seniors who reside in 95050 reported that their sidewalks are in "good" or "excellent" condition.




reside in 95051 reported that their *sidewalks are* in "good" or "excellent" condition. More than 90% of seniors who reside in 95054 reported that their *sidewalks are* in "good" or "excellent" condition.

Walking distance to basic services is "excellent" or "good" for Young-Old (60%), Middle-Old (50%), and Oldest-Old (50%). More than half (58%) of those who live in 95050 report the walking distance to basic




services as being "excellent" or "good". More than half (56%) of those who live in 95051 report the walking distance to basic services as being "excellent" or "good". Half (50%) of those who live in 95054 report the walking distance to basic services as being "excellent" or "good".

Seniors report that there are enough crosswalks at intersections and ramps at curbs so you can walk from home to basic services.



Across three ZIP codes (95051, 95050, 95054) almost 60% of seniors report having a plan to survive the first three days of a natural disaster without



electricity, water, or emergency assistance.



Aging in Place.44 The majority (86%) of Santa Clara seniors plan to remain

in their current residence as they age. As seniors age, the desire to remain in their current residence solidifies 76% of Young-Old, 90% of Middle-Old, and 95% of Oldest-Old.




3.8 Communication⁴⁵

The Santa Clara Senior Center is the most popular place to look when information about senior services is wanted. Half as many seniors use the Internet or reach out to a friend or relative as a source of information. More than 75% of Santa Clara seniors use the Internet. For the 25% who do not the most common reason reported is "no computer" followed by "lack of interest". For the 75% of seniors who do use the Internet, most use it for: email, research, news, and shopping. While over-all, seniors preferred to get information from *Inside Santa Clara* and the Newspaper (18%), several other methods closely followed for seniors' preferences: the Internet or email (17%); and, the utility bill insert (15%). The Young-Old, as a group prefer Internet and Email, while the Middle-Old and Oldest-Old prefer more traditional methods Newspaper and Television. About 11% of seniors report preferring information from cable channel 15.



3.9 Transportation and Access 46

The majority of all seniors report using either a car or motorcycle as their primary means of transportation (90% Young-Old, 85% Middle-Old, 75% Oldest-Old). For all seniors, the second most popular option is to walk (40% of Young and Middle-


Old, 24% of Oldest-Old). About 32% of the Oldest-Old are likely to ask a friend or relative for a ride. Over 20% of the Young-Old report using a bicycle. Across age groups, about the same number (10%) report riding a bus. About 10% of the


Oldest-Old use Outreach and 5% of the Young-Old use light rail. Across age groups fewer than 2% of seniors report using a not-for-profit organization for transportation.

Public Transportation.⁴⁷ For those who do not use public transportation (bus, Outreach, light rail) the reasons vary across age groups. Young-Old cite time

(30%), routes (24%), and frequency (14%) most often as reasons why they do not use public transportation. Middle-Old report routes (25%), time (22%), and too far to walk to station (13%),



If you do not use public transporation, what prevents you...



or does not come often enough most frequently as reasons why they do not use public transportation. The Oldest-Old report time (24%), routes (24%), and frequency (13%) most often as reasons why they do not use public transportation.

Senior Shuttle Service. 48 About 52% of all seniors report they would use a

shuttle bus service to get to locations within Santa Clara. However, 53% of the Young-Old would not use a shuttle service, while 53% of the Middle-Old would,



along with 56% of the Oldest-Old.

PART FOUR: SUMMARY COMMENTS

From April through October 2012, the Senior Advisory Commission reviewed the Senior Needs Assessment results with staff. This section provides summary comments in the eight areas of focus: Health and Nutrition, Social, Finances, Support/Activities, Safety, Housing, Communication, and Transportation and Access. For each of these focus areas, the survey results prompt questions for further reflection: Are there opportunities for improved services or programs? Can existing resources (time, personnel, funding, facilities, other) be redeployed to more effectively serve the needs of Santa Clara seniors? Are there existing or potential collaborative partnerships that can be explored and leveraged to support senior programs and services? While the answers to these questions were beyond the scope of the 2010 Senior Needs Assessment, U.S. Census data indicate that an increased demand for services will continue as seniors age in place and grow as a percentage of the population. It is important to note that a policy or programmatic decision may have different effects on each of the three distinct senior sub-groups: the Young-Old (50-64), the Middle-Old (64-79), and the Oldest-Old (80+). The City has a unique history, a collaborative approach, and strong ethics and values to guide its decisions.

4.1 Health and Nutrition

The survey results point to several ways in which older adults can be served in terms of health and nutrition. At the Senior Center, there exists a state of the art fitness center and natatorium, a unique health and wellness program, a well-attended nutrition program, and diverse opportunities for social engagement. The Parks and Recreation Department is uniquely positioned to use the data from this survey to deliver a high level of service that has a positive impact on the senior community. The Senior Advisory Commission values and appreciates the quality

of health and nutrition services offered to Santa Clara's senior community and note that those who are unable to avail themselves of these services primarily cite the reason as a lack of transportation. The Senior Advisory Commission recommends continued support of current health and nutrition services being provided.

4.2 Social

Social engagement is known to be a significant factor in a person's well-being and in their continued ability to live independently. Different models exist to support the Oldest-Old and encouraging the use of the spectrum of community services. While there are many opportunities for social engagement at the Santa Clara Senior Center and throughout the City, 40% of the respondents do not use the services of the Senior Center. The Senior Advisory Commission found that a lack of coordination, communication, hours of service, and in some cases lack of transportation somewhat hampers senior's ability to avail themselves of these services.

4.3 Finances

Across age groups, most seniors report being able to pay for routine expenses, paying for an unexpected major expense was reported to be difficult. Although the survey assessed data based on U.S. poverty levels, the Elder Economic Security Standard Index developed by the University of California at Los Angeles Center for Health Policy Research in 2007, found that the median monthly expenses for a Santa Clara County senior, single and living alone, are in excess of \$30,000 per year which is more than three times the level of the national poverty index. Consequently, although the Senior Needs Assessment 2010 survey did not find a significant poverty level in Santa Clara seniors, reexamination of this issue may find a more significant poverty issue among Santa Clara seniors.

4.4 Support/Activities

Santa Clara seniors report needing help with Activities of Daily Living (ADL). The Oldest-Old are most likely to need this type of assistance. Assistance with transportation, cleaning, legal services, and shopping are most commonly reported as being needed. Seniors usually rely upon a friend or relative to provide support; private pay services are another alternative used. The Senior Needs Assessment 2010 found that there are many services available to seniors in Santa Clara. Among them are services offered at the Senior Center as well as through other community agencies, both private and public. However, the lack of awareness of what is available indicates more coordination and communication about available programs and services to seniors is needed.

4.5 Safety

Most Santa Clara seniors feel their neighborhoods are safe, and street lighting and sidewalk conditions are excellent or good. Continued efforts in these areas will support aging in place. Additional efforts in emergency preparedness for seniors and volunteers is needed.

4.6 Housing

More than half of all seniors in Santa Clara own their own home. Most seniors plan to remain in their current residence as they age. Approximately 20% of the Oldest-Old reside in senior residential housing and fewer than 3% live in an assisted living facility. A continued support of home ownership and other appropriate living spaces supports seniors, particularly affordable housing and assisted living options for Santa Clara seniors will help to meet the increasing senior population growth and need.

4.7 Communication

Approximately 75% of seniors report using the Internet. Seniors report that they like to receive information through *Inside Santa Clara* newspaper, followed by the "newspaper", Internet, utility bill insert and Adult Education Catalog. The Santa Clara Senior Center is the most popular place to look when seniors look for information about services. Continued and increased effective promotion and use of technology and social media can provide news and information about programs and services available. Further study is needed to identify ways to interact with homebound seniors to connect with critical City services.

4.8 Transportation and Access

While more than 90% of all seniors report that they drive and depend on private vehicles, alternative transportation models that are less costly, more environmentally friendly, and safer could be explored. Approximately 40% of those surveyed responded that they would avail themselves of services at the Senior Center if there were better modes of public transportation. The Senior Advisory Commission recommends further study.

In June 2009, the Santa Clara City Council adopted a goal of assessing the needs of Santa Clara seniors in collaboration with the Senior Advisory Commission and non-profit agencies. In October of 2012, Senior Advisory Commission and staff thank the City Council for recognizing the unique needs of the senior community and hope that the results of the Senior Needs Assessment will help the City improve upon the already excellent services offered to Santa Clara seniors.

PART FIVE: SURVEY DATA TABLES

This section provides summary data tables for responses by age group to each survey question, in numerical sequence. In most cases, the tables provide data by each sub age-group: Young-Old; Middle-Old; and, Oldest-Old. The final table (or columns in the table) for each question will provide a summary of all seniors responses to the particular question. Generally, tables for each age group provide the data in descending order from most number of responses to least number of responses.

Not every survey participant responded to each question or part of a question. Many questions have multiple variables. This will cause the total number of responses recorded for each question and age group to vary, as well as the count of the total responses for each question. It is important to note that the tables accurately reflect the total responses recorded for the age group responses, as well as the total responses.

The data seen in **bold** generally allows the reader to note a single data item and how it is reflected in each age group, allowing for easier identification of differences among age groups.





- The age range is from 50 to 95 with the average age of 68.6. A breakdown of the ages by year is included.
- There are 227 seniors living alone.
- Of the 629 responses, 441 use the Library.
 - --- A common complaint is that there is too much traffic at both the Library and Swim Center.
 - Being out after dark is the number one fear reported on the survey. This includes driving and walking at night, as well as fear of the youth gangs.
