Jay Shechter is currently the Division Director of Housing and manages 804 rental apartments built and owned by the City of Pembroke Pines. Currently, he is Project Director of the S.W. Focal Point Senior Center since May of 2009. Mr. Shechter has been instrumental in updating and modernizing the center by adding Wi-Fi for internet users, additional day & evening classes, an exercise room with work out machines for the members' use.

Also under his wing is the new project called R & R Village (Re-Connect and Re-Energize) consisting of five 5-bedroom homes that are rented exclusively to vets and various additional Veteran-related programs including career expos, memorials and a Commemorative Partner with the United States of America 50<sup>th</sup> Anniversary of Vietnam War Commemoration.

The City of Pembroke Pines has several departments and opportunities throughout the city that are open to volunteers. Parks & Recreation, Police and Fire, City Hall and the Community Services Department all have areas where volunteers are utilized. These are just the departments among the municipality. Also available City-wide are libraries, hospitals, schools and church organizations.

The Southwest Focal Point Community Center offers many events, activities, classes which volunteers have opportunities to be active on a daily basis. The Adult Day Care facility, run by Easter Seals South Florida, provides daily care to those frail & elderly adults with dementia and also utilizes volunteers.

The City will provide areas that interest older adults who want to get involved actively such as encouraging them to serve on City boards, volunteering in schools' reading programs, participate in many of the City events like annual Pines Day celebration & holiday events.
