Three-year Action Plan for **Sham Shui Po District**

Background

Initiated and funded by The Hong Kong Jockey Club Charities Trust, the Jockey Club Age-friendly City Project ("JCAFC Project") aims to build Hong Kong into an age-friendly city. The Institute of Active Ageing ("IAA") of The Hong Kong Polytechnic University ("PolyU") has conducted the baseline assessment study between May 2017 and August 2017 to gather the views of Sham Shui Po residents on the age-friendliness of the District with reference to the eight age-friendly city domains within the World Health Organisation ("WHO")'s Global Age-friendly Cities framework. A total sample of 513 questionnaires were collected and five focus group interviews were conducted in Sham Shui Po District. The baseline assessment findings identified local residents' concerns in each domain which shed lights on developing a three-year action plan to make Sham Shui Po District a more age-friendly community.

Consultation meetings were organised to discuss the baseline assessment findings and three-year action plan with Sham Shui Po District Office and District Council since October 2017. The major concerns in eight domains revealed by the baseline assessment study were highlighted as follows:

Domain 1) Outdoor Spaces and Buildings

The outdoor environment has a great impact on the mobility of residents and their quality of life. Although the accessibility of parks and public leisure grounds was appreciated by older people, elderly fitness facilities and shelters were insufficient. Insufficient seating spaces in shopping malls, environmental hygiene problems (e.g. rodent problem, mosquito breeding and spitting in the street), insufficient shelters in pedestrian walkway and occupation of public spaces by some shops were other key concerns highlighted by local residents.

Domain 2) Transportation

Good transport network and the entitlement for Government Public Transport Fare Concession Scheme for older people aged 65 or above were the major age-friendly initiatives appreciated by the respondents. There was room for improvement on the attitude and behaviour of public transport drivers towards older people. The insufficient provision of age-friendly facilities in

public transport services, high transport fee for residents aged 64 or below and the concern about the insufficient transport services in new and redeveloped areas were other key concerns raised by local residents.

Domain 3) Housing

Housing is a major concern in the district. Apart from small living space, the rent of sub-divided flats was unaffordable for grassroots older people. Without the provision of barrier-free access facilities, the mobility of older people who lived in tenement houses was largely reduced. Moreover, home modification services were either limited or unaffordable for older people.

Domain 4) Social Participation

Affordable program fee and the availability of different social activities for active older members to participate in were major elements appreciated by the respondents. Insufficient activity quotas and limited opportunities for hidden and singleton elderly to participate in social activities are the major areas which require improvement.

Domain 5) Respect and Social Inclusion

Active older people who are concerned about the community development and are willing to share their views expressed that it was quite difficult for them to review the follow-up actions after their opinions were raised. There was insufficient opportunity for intergenerational interaction which was essential to foster understanding and appreciation among different generations. Age-friendly initiatives, such as priority seats in public transport vehicles and discounts offered by restaurants, were available, but more promotion was needed to enhance older people's awareness.

Domain 6) Civic Participation and Employment

Older people were capable and their strengths and experience could be further utilised through volunteer opportunities. Meanwhile, a number of factors had been remarked as barriers for older people to enter the labor market, such as age discrimination and the introduction of Statutory Minimum Wage. Some district councillors recommended that job matching services between

potential employers and older people should be strengthened so that more job opportunities could be provided to older people.

Domain 7) Communication and Information

The availability of different channels (e.g. elderly centres, radio and television) for active older people to receive information was appreciated by the local residents. However, singleton and hidden elderly still had difficulties in accessing district-related information. Other barriers to age-friendliness included difficulties in adapting to the digital era and making medical appointments through the General Out-patient Clinics Telephone Appointment System.

Domain 8) Community Support and Health Services

In general, the local residents considered that the public medical services were affordable. However, the long waiting time for out-patient specialist services in public hospitals and the limited quotas for general out-patient clinics affected older people to receive timely treatment. Although community support services were available, there was a concern about its accessibility to hidden and singleton elderly. Obstacles for older people with mobility difficulties to access to health services and insufficient support to promote a healthy lifestyle among older people were other major challenges to age-friendliness.

Proposed Three-year Action Plan of Sham Shui Po District

Based on the baseline assessment findings and comments from Sham Shui Po District Office and District Council, the following three-year action plan has been developed for improving age-friendliness of the District.

Domain 1) Outdoor Spaces and Buildings
