- The cycle 1 plan was established with a three-year plan aimed at certifying an elderly-friendly city (2020-2022)
- O Vision: Happy Gwangju, the City of 100-year Longevity with No Worry for Aged Life
- Goal: Making social and physical environment for happy later years life
- O Strategies: 5 areas, 11 units, 49 detailed plans



#### ☐ Promotion direction and system

- Promotion direction
  - Evaluation of the performance of unit projects by sector in the previous year and reflection on the implementation plan for each unit project in accordance with the three-year master plan policy
- (Expansion of jobs, culture, and leisure) Expansion of cultural leisure programs by reflecting the preferences of the elderly and finding various jobs suitable for the elderly and the middle-aged
- (Establishment of care for the vulnerable) Establishment of a tight social care network for the elderly in the vulnerable class, such as living alone, low income, and abuse damage, which are constantly increasing
- (Disease Prevention and Public Care) Reduction of personal medical and medical care burden by preventing and managing the rapidly increasing number of geriatric diseases such as dementia and strengthening public care
- (Improvement of living environment and accessibility) Establishment and improvement of safe and convenient living environment and improvement of access to welfare services where the elderly live comfortably
  - Re-enrollment(certification) of age-friendly cities of World Health Organization and discovery and promotion of policies customized to the elderly by vitalizing the policy monitoring group by the elderly
- (Period) '21.4. ~ '22.12. (1st term: '21.4. ~ 12. / 2nd term: '22.1. ~ 12.)
- (Composition) About 20 people per term (considering gender, participattion of various ages)
- (Content) Participate in monitoring 49 plans in 5 areas of the implementation plan and discovering age-friendly policies


#### Promotion system

- ▶ Establishment and operation of a public-private partnership system
  - Establishment and operation of a bottom-up public-private partnership system throughout the process of implementing policies for the elderly, such as policy discovery, review, inspection, evaluation, service delivery, and implementation



- Operation of the Committee: strengthening public-private cooperation and imparting expertise and implementation skills throughout the policies for the elderly
- people including experts, officials from related organizations, city councilors, and public officials
- Consultation, policy coordination, and evaluation of implementation plans in relation to the creation of an age-friendly city
- Establishing and implementing policies, delivering services, and conducting on-site activities through participation of city, Gu, institutions, and organizations
- Operation of the monitoring group: activating communication with policy targets and establishing bottom-up policies
- It consists of about 20 senior citizens who use welfare facilities for the elderly, experts, field practitioners, etc.
- Collecting policy opinions, discovering plans, inspecting, etc. (Interview survey on facility visits, etc.)
- Gwangju Metropolitan City, Gwangju Welfare Research Institute, and Senior Welfare Center participated as planning, management, and cooperation institutions
- ► Implementation of the management system as the member cities of WHO Global Network for Age-friendly Cities and Communities
  - Establishment and implementation and evaluation of the plan for the cycle 1 (3 years) at the time of first enrollment
  - After completion of the cycle 1 (3 years) implementation, the cycle 2 (5 years)

plan is established, implemented, and evaluated repeatedly

# 1) Progress of the promotion of age-friendly city

- Planning, investigation and research, establishment of public-private cooperation system, projects by field, etc.
- Holding a collaborative meeting of departments related to the creation of an age-friendly city ('19.4.)
- In charge of 11 departments, etc / report on the implementation of the development plan and discussing ways to establish it
- Meeting of the advisory committee on the creation of age-friendly City ('19.7.~11.)
- Discussion of organization and academic experts, city councilors, public officials, etc.

- Meeting of the age-friendly city development committee and deliberation on the basic plan for development ('20.1.)
- Debating the basic plan for the 3 year of the creation of age-friendly city ('20-'22)
- Establishment of a promotion plan for the construction of age-friendly city in 2020 ('20.2.)
- Establishment of 2020 promotion plan (49 plans in 5 areas) according to the basic 3 years plan ('20-'22)
- O Joining the WHO Global Network for Age-friendly Cities and Communities ('20.3.)
  - Establishment of a promotion plan for the creation of age-friendly city in 2021 ('21.2.')
  - Establishment of 2021 promotion plan (49 plans in 5 areas) according to the basic 3 years plan ('20-'22)

# 2) Details of implementation

- O Contents of support project for the elderly: aiming to ensure the settlement environment and quality of life for the elderly in various areas such as expanding customized welfare, social participation, and income—based support in consideration of the characteristics and situation of the elderly
- ▶ Participation in social activities for the elderly and expansion of income—based support after retirement
  - Support for public-led continuous discovery of jobs such as public interest type,
     market type, and social service type
  - Size of participation in jobs for the elderly 21,563 people in 2019, 27,584 people in 2020, 27,575 people in 2021
  - Minimizing income gaps for the elderly through flexible business operations such as adjusting business hours and personnel due to COVID-19
  - Opening of Bitgoeul 50+ Center, a platform that comprehensively supports the second act of life of the elderly, and preemptively supporting the elderly from the prospective generation through customized job support
  - Opening of Bitgoeul 50+ Center, which provides comprehensive support for redesigning life, such as work, leisure, and education for the elderly (21.10)
  - Support for 534 people by customized jobs using experience and expertise (social contribution activities, jobs in Bitgoeul 50+)
- Expansion of care services and welfare infrastructure for the elderly in

#### vulnerable group

- Improving service efficiency by integrating and supporting elderly care projects customarily centered on demand and needs, and strengthening accessibility and responsibility of business performance agencies
- Support target (13,081 people), increasing provision manpower (827 → 909 people), service diversification, etc
- Integrated support for "customized care services for the elderly" and provision of care services by district (19 performing organizations)
- Responding the needs of welfare services for the elderly by continuing to expand the cultural and leisure infrastructure
- Construction of Senior Citizens' Center (opened in April 2021), construction of complex facilities for senior citizens in the western region (performance of preliminary procedures, construction start in 2022)
- ▶ Creating an age—friendly city to actively respond to the aging society
  - Establishment of a basic plan for the creation of age-friendly city, operation of a committee, and implementation of the management system as the member city of WHO Global Network for Age-friendly Cities and Communities
  - Establishment and implementation of the plans for the creation of age-friendly city (49 plans in 5 areas)
  - Operation of age-friendly city development committee and operation of Senior Policy Monitoring Group

## 3) Promotion plan for each area

## (1) Support of jobs for the age for lively later years

☐ Support of jobs and social activities for the aged

O Expanding and enhancing opportunities to participate in jobs for the elderly (Supporting 28,350 people in 2022)

- Public interest type (24,169), social service type (1,796), market type (1,555), and job placement (830)
- Strengthening of activity capabilities and autonomous indicators to expand opportunities for the elderly to participate
- Promotion of substantialization of participants' competencies and education according to the characteristics of each job type
- O Integrated database management to provide customized jobs for the elderly
  - Establishment and operation of a comprehensive job support system, such as the operation of the elderly job portal system, the provision of job information for the elderly and the job placement (operation of Gwangju Senior Club)
- O Support for the operation of a institution specialized to jobs for the elderly(senior clubs) and expanding infrastructure
  - Support for finding and operating jobs for the elderly of senior clubs (5 locations) (KRW 1,504 million)
  - Expansion of support infrastructure for job institutions (creating customized education and job linkage system for new institutions)

# ☐ Support of life redesign for the middle and old aged

- Operation of Bitgoeul 50+ Center, a comprehensive life redesign support organization for the elderly
  - 403 m² of shared space (book cafe), information center, education room, club room, and counseling room, etc. (Hakdong)
  - Support for life redesign counseling and consulting for the elderly, employment and start-up, education and training, community activities, etc
- O Support for social contribution type and career type job utilizing the career and expertise of the elderly.
  - 320 people in jobs in Bitgoeul 50+ (city's own business, social contribution type)
  - 75 people in experienced work of the new elderly (Ministry of Employment and

Labor's business, career type)

- 20 people, professional personnel of the new elderly using agricultural machinery (education and certification, on-site internship)
- O Revitalizing start—ups and creating local jobs by finding prospective middle—aged entrepreneurs with expertise (Information and Culture Industry Promotion Agency)
  - Package support such as start-up space, education, expert advice and network,
     commercialization, etc

### (2) Activation of the social participation by the aged for active later years

#### ☐ Activation of culture & leisure for the aged

- O Expansion of welfare services by expanding and operating leisure welfare facilities for the elderly
  - (senior welfare center) 7 locations (city 1, Gu 6) Operating expenses, labor costs, etc. (KRW 1,832 million)
  - (senior class) operating expenses for 42 locations (KRW 84 million)
  - (senior citizen center) operating cost and functional reinforcement cost of 1,343 locations (KRW 3,943 million)
- O Improving the environment for using information and communication at senior citizen centers and activating the use of programs
  - Installation of public Wi-Fi in all senior citizen centers, access to information,
     and activation of leisure activities (KRW 226 million)
  - Establishment of welfare center-type senior citizen center (KRW 100 million, supporting remodeling of around 5 locations per year)
  - Providing customized cultural and leisure programs to senior citizens using the senior citizen center (placing 9 program managers)
  - Support for establishing new senior citizen centers in small apartments without senior citizen centers (2 places / Nam-gu)

- Innovation operation of specialized welfare facilities for the elderly (Bitgoeul and Hyoryeong Town)
  - Operation of online specialized programs linked to external organizations, operation
    of "Dream Tree Cafe" for the elderly's jobs, promotion of various social contribution
    projects such as Bitgoeul Social Contribution Camp Group, Bitgoeul Cooking
    Coordination Project Group, etc.
  - Focusing on job welfare for the elderly and middle-aged (Adding health, 5.18 proper notification, crackdown project on hidden cameras, etc.)
- O Supporting sports activities to promote the health of the elderly and holding the National Senior Health Festival
  - Five events and awards such as Baduk and janggi(Korean chess game), Korean archery, ground golf, gateball, badminton, and etc.
  - Holding the National Senior Health Festival (October, 2 days) with 3,000 senior athletes from all over the country

## ☐ Expansion of opportunities for the social activities by the aged

- O Providing opportunities for development and activities to satisfy the elderly's self-realization and social participation needs
  - Training of front-line elderly leaders who can lead the elderly's social participation activities (70 people per year)
  - Conducting information education such as smartphone mobile use and computer basics (about 5,000 people per year in 4 institutions)
  - Purchasing and providing large type books (about 1,000 books per year), operating reading programs for the elderly (3 programs)
- Operation of the 'Senior Policy Monitoring Group (cycle 2)' to check the promotion plan for the creation of age—friendly city
  - 2022. 1. ~ 12. / 20 people / monitoring 27 plans in 3 areas of the promotion plan
     / collecting opinions on improvement and discovering plans

- O Support for the organization and operation of volunteer activities for the elderly
  - Support for the operation of volunteer club organizations, activities, education, public relations, and related projects (126 clubs per year)

#### (3) Strengthening of care welfare for the aged for carefree later years

#### ☐ Provision of systematic senior welfare service

- O Support for expanding customized care services to the elderly in vulnerable groups (KRW 17,987 million)
  - Support target (13,800 people) in 2022, increasing provision manpower (909 → 917 people), service diversification, etc.
  - Integrated support for customized care services for the elderly and provision of care services by region (19 locations in autonomous districts)
- O Establishment of a system for preventing sexual violence and supporting for customized care workers for the elderly
  - Organization and operation of a specialized organization related to sexual violence (sexual harassment, sexual molestation) and production and distribution of response manuals
  - Prevention education, handling of cases, and follow-up management of persons related to customized care for the elderly
- O Support for providing free meals and delivering lunch boxes for the elderly who are concerned about skipping meals (KRW 3,750 million)
  - 29 senior citizen restaurants (KRW 3,497 million), delivery of lunch boxes for the elderly with mobility difficulties (669 people)
- O Basic pension payment for stable income-based support for the elderly (KRW 484,833 million)
  - Providing up to KRW 300,000 per month to the elderly aged 65 or older and whose income is below the criteria

# ☐ Enhancement of human rights of the aged and expansion of respect culture for the elderly

- O Prevention of elder abuse and protection of the abused elderly
  - Systematic and professional response to elder abuse, such as case reception,
     counseling, and on-site investigation
    - \* Operation of case judgment committee consisting of experts from all walks of life (9 people, once a quarter)
  - Temporary protection of the abused elderly, provision of psychological counseling programs, medical support, etc.
  - Improving awareness of perpetrators through education (250 times) and promoting prevention and reporting through publicity (3,000 times)
- O Conducting the elderly human rights education for workers in living facilities used by the elderly (2,300 people a year)
  - Education of laws and systems related to the elderly human rights, cases of human rights violations, guidelines and procedures for reporting human rights violations, etc.
- O Encouraging filial piety and creating a social atmosphere in which filial piety is practiced \*Private offering
  - Public-private partnerships to provide filial piety experience learning and human rights education to local students (1,000 students per year)
  - Various commemorative events such as Parents' Day and Elderly's Day and spread
     of welfare for the elderly and filial piety culture

#### (4) Support of health and care services for the aged for healthy later years

#### ☐ Health improvement of the aged

- Operation of a health center for the elderly who use the center for the elderly in vulnerable areas (circular medical treatment)
  - Supporting doctors in charge of senior citizen centers and providing basic medical services (250 locations per year)
  - Health promotion program operation and health check (blood pressure, blood sugar, osteoporosis test, etc.)
- O Visiting health management for the vulnerable in health care (older people living alone, mobility-impaired elderly people) (about 1,800 households per year)
  - Systematic management and health education of people with chronic diseases such as high blood pressure and diabetes in connection with public health center resources
  - Prevention of complications, heat waves, falls, depression, dementia management, etc.

# ☐ Establishment of dementia prevention and management infrastructure and provision of long-term care services

- O Promotion of the construction of a complex for the elderly in the western region specializing in dementia prevention
  - 2019 ~ 2024(6 years) / Viadong, Gwangsan-gu / 22,173m² of land and 8,100m² of total ground area
  - Specialized (prevention of dementia) senior welfare center, national sports center and small library
- O Expansion of day and night care facilities dedicated to dementia
  - Reinforcement of functions of nursing homes for the elderly (5 locations, KRW

#### 1,269 million)

- Expansion of dementia-specific nursing facilities (2 locations, KRW 2,799 million, completed in July 2022)
- Operation of dementia relief centers for dementia management and prevention services (5 locations in total)
  - Providing services such as registration of dementia patients, counseling and early examination, case management, etc.
  - Short-term dementia shelter (daytime protection) and dementia cafe operation (family manager), etc.
- O Support for long-term care services for the elderly with geriatric diseases
  - 4,919 people with grades (grades 1 to 5) and recognition grades / facility benefits (admission), home care benefits (visit), etc. (KRW 48,000 million)
  - 10 non-rated people / support for nursing home use (KRW 222 million)

## ☐ Development and support of age-friendly industry

- Operation of age-friendly industrial support center (Gwangju Science and Technology Center)
  - Development and commercialization of dementia and fall prevention technology, development of the age-friendly medical device industry, etc.
  - Product experience, life experience, and support for age-friendly companies such as technical guidance and marketing, etc.
- O Development of dementia prediction technology (National Dementia Research Group in Chosun University)
  - Support for the production and demonstration of medical devices for early diagnosis and prediction of dementia
  - Development of an AI-based demonstration test bed for dementia data application (2021~2025, Gwangju TP, KRW 20 billion)

# (5) Improvement of living environment for the aged for pleasant later years

#### ☐ Enhancement of traffic safety convenience for the aged

- O Expansion of senior protection zones and establishment of traffic safety facilities
  - Maintenance of facilities (integrated signs, road markings) in the senior protection zones (52 locations) and installation and maintenance of traffic safety facilities
- Conducting on-site traffic safety education to improve traffic safety awareness for the elderly
  - Visiting senior citizen centers (pedestrian accident black spot, etc.) and conducting safety education such as preventing traffic accidents (70 times a year)
- Guide elderly driver's license return (support for transportation expenses)
  - Distribution of transportation cards (KRW 100,000) to elderly drivers aged 70 or older when returning their driver's licenses (2,000 people per year)
- Building barrier-free stops, expanding the introduction of low-floor buses, and training transport workers' services
  - Improvement of bus stop environment on low-floor bus routes (installation of braille blocks, removal of obstacles, etc. / 10 locations)
  - Introduction of low-floor buses to improve transportation convenience for the vulnerable in traffic (45 vehicles per year)
  - Providing human rights education for the vulnerable in traffic to transportation workers (2,400 people per year)

# ☐ Environmental improvement of living space for the aged

- O Prevention of environmental diseases in elderly activity spaces such as older people living alone and senior citizen centers (20 households per year)
- O Single-generation green remodeling such as barrier-free space and energy performance improvement of small permanent rental apartments (750)

households in 3 complexes)

- Expansion of area for exclusive use by remodeling (7 pyeong, 2 households ⇒ 14 pyeong, 1 household), induction of children's union of older people living alone , etc.
- O Support for emergency safety services for older people living alone and disabled people (3,000 households, KRW 1,141 million)
  - Installing fire, gas detectors and activity sensors to automatically call and respond quickly in case of an emergency
  - Safety accident prevention and response management in connection with 119 safety centers, emergency management personnel, and care life support personnel
- Education and support for safety products to prevent falls for the elderly
  - Installation and support of safety supplies to prevent falls for elderly people such as safety handles (1,300 people, KRW 200 million)
  - 1:1 direct training about safety rules and countermeasures for falling accidents when supporting and installing goods

# 4) Annual budget

#### ☐ General affairs

- O A total budget of KRW 1,901,915 million has been set up over three years for major projects in 11 field of 5 major areas for the creation of the first age-friendly city, and it has been steadily increasing since 2019
  - By the 5 major areas, reinforcement of care welfare (including basic pension) accounted for 68.2% of the total budget with KRW 1,299,617 million, job support 15.5% with KRW 294,211 million, health care service support 11.5% with KRW 217,874 million, living environment improvement 2.8% with KRW 53,722 million, and social participation activation 1.9% with KRW 36,491 million.

- O 7 of 10 plans related to job support for the elderly have achieved the goal, including support of jobs and social activities for the aged, operation of the elderly job portal system, senior club operation support, operation of public-private partnership system, rural job of the new elderly, revitalization of start-up support center for the middle and old aged, and establishment of Bitgoeul 50+ center.
- O Social contribution and career jobs of the new elderly is the weakest at 17.6%, jobs in Bitgoeul 50+ 72.0%, and customized redesign support 97.5% are slightly below the target.

# 1) Background and purpose of operation

- ☐ The Gwangju Metropolitan City senior policy monitoring group is a project to join and maintain the membership of WHO Global Network for Age-friendly Cities and Communities
- O The senior policy monitoring group is meaningful in implementing the WHO's recommendation that the opinions of the parties should be reflected in the creation of an age-friendly city and establishing a governance system to collect voices from local sites.
- O In order to create an age-friendly city and community environment, it is intended to identify the needs and opinions of the elderly and reflect the relevant contents in the action plan and administration of the age-friendly city.
- O It encourages the elderly to be interested in aging and aging society policies, and provides opportunities to continuously convey opinions and suggest alternatives.
- O It aims to promote policies related to the creation of age—friendly communities through monitoring activities, guide specific projects, and enhance the citizens' policy experience level in Gwangju Metropolitan City.

# 2) Role and expected effect of monitoring group

#### (1) Role

- O Improving age-friendliness level in Gwangju through monitoring activities
- O Promoting the elderly welfare and elderly social policies in Gwangju and sharing performance.
- Maintaining the membership of WHO Global Network for Age-friendly Cities and Communities and providing best practices
- O Suggesting the direction of senior citizens' policies to create a better environment for all citizens to live in

# (2) Expected effect

- O By joining the WHO GNACC, it is possible to benchmark by participating in exchange of policy information with cases of countries and cities that have already entered an aging society
- Free social and economic participation of the elderly enables the elderly to live independently and can resolve social costs, manpower, and generational conflicts caused by supporting the elderly.
- O An age-friendly urban environment forms a bond with social relationships of all generations and can provide opportunities for residents to interact.
- O It is expected to improve the quality of life not only for the elderly but also for all members of the community, and it can positively contribute to the economic, social, and cultural lives of all citizens.

# 3) Progress of business operation

#### (1) Operational Matters

- The Gwangju Metropolitan City senior policy monitoring group is linked to the Gwangju Metropolitan City career—type aenior job project.
  - 1 person in charge, 28 senior citizens (18 people in 2021, 11 people in 2022), and 6 months monitoring (June November)
- O Recruitment for unemployed senior citizens aged 50 to 70 related to career—type job projects
  - Most of them have a social worker level 2 certificate. The monitoring group is divided into 4 teams (Seo-gu, Nam-gu, Buk-gu, and Gwangsan-gu)
- O Monitoring is conducted through surveys and an individual questionnaire response from the person in charge of operation by complying with quarantine rules by utilizing social distancing and Zoom related to COVID-19.

O Senior policy monitoring group for the creation of an aging-friendly city in Gwangju Metropolitan City is two areas of promotion, job support and activation

of the social participation.

- Area for job support consists of 2 promotion tasks and 10 detailed plans, and area for activation of the social participation consists of 2 promotion tasks and 12 detailed plans.
- In accordance with the government's policy on social distancing related to COVID-19, non-face-to-face question-and-answer sessions using Zoom with operators of operating institutions, visits to facilities, and direct participation in social distancing mitigation are used when monitoring the detailed plans.

#### ① Area for job support

- In the area of job support for the elderly, the supply of customized jobs for the elderly for the vibrant retirement, the establishment and operation of an information platform for the elderly, and the operation of an institution dedicated to jobs for the elderly have been promoted as the major project.
- Tasks in support of jobs and social activities for the aged mainly suggested improving the treatment of participants, such as improving the treatment of senior job managers and raising the cost of activities of job project participants, and the need for suggestions to the central government has emerged.
- Proposal on the importance of promoting the elderly job portal system so that the elderly can easily access it
- There is a lack of promotion strategies for the middle and old aged generations to easily find information, and it is considered necessary to develop a business field that can redesign their lives in a long-term and stable manner rather than a short-term business.
- In the case of rural job of the new elderly, it is necessary to redesign the project due to the absence of a utilization plan after obtaining the relevant certificate.
- Start-up support center project for the middle and old aged needs to seek diversification of start-up education programs to enable start-up activities in various fields other than digital information technology.
- As Bitgoeul 50+ Center was established in 2021, employment programs and

networks building in various regions are first needed to serve as a hub for connecting the jobs for the middle and old aged in Gwangju.

#### ② Area for activation of the social participation

- In the case of public leisure facilities at Gwangju Park Welfare Center, as the accessibility decreases, it is necessary to review the operation of shuttle buses, etc., and the necessity of regional linkage projects with nearby residents emerges.
- In the case of Bitgoeul Senior Health Town and Hyoryeong Senior Welfare Town, as a large-scale leisure facility for each district, it is necessary to open various and excellent facilities to nearby residents, reconsider the utilization rate of vulnerable groups such as basic living recipients and the secondary poor class, and seek differentiated operation strategies from welfare centers in each autonomous district.
- In order to revitalize sports for all, it is necessary to activate sports facilities near apartment complexes and residences, and to produce and distribute videos that can be easily followed during COVID-19 period.
- It is necessary to actively review ways to make it easy for the elderly to share information through various promotions related to the management of the senior leadership university and to utilize it after completion of education.
- The operation of informatization education for the elderly requires consideration so that the elderly can easily learn how to use informatization devices by expanding informatization—related education and programs according to the informatization society and introducing auxiliary instructors.
- The provision of age-friendly library services requires active promotional activities due to the lack of publicity among many elderly people regarding the status of large-type books.
- The senior policy monitoring group needs to reduce the number of monitoring participants and come up with measures to strengthen education so that they can fully understand each area's indicators and conduct monitoring activities in the field

#### 3 Area for strengthening care welfare

- In comprehensive evaluation of three detailed plans for providing systematic welfare services for the elderly, provision of customized care services for the elderly and delivery of free meals and lunch boxes were evaluated as excellent.
- Regarding the provision of customized care services for the elderly, it emphasizes the need to improve the treatment of life support providers directly related to the quality of care services, and suggests flexible services provision to meet the demand for care services experiencing support burden, emphasizing the relaxation of the criteria for selecting targets reflecting various environmental conditions surrounding the elderly.
- It proposed a thorough delivery system to expand the number of people eligible for free meals and lunch boxes, minimize waiting time, and prepare countermeasures for the elderly in blind spots
- Regarding basic pension payment, it suggested the necessity of adjusting the age
  of the target and the importance of promotion related to application, and made
  policy suggestions on the reality that many elderly people are not well aware of
  various age-friendly projects.
- In the comprehensive evaluation of four detailed plans related to improvement of awareness of elderly human rights and spread of filial piety culture, human rights education for elderly welfare facilities workers was excellent, but cultivation and spread of filial piety culture was insufficient.
- Regarding operation of the shelter for the abused elderly at an institution specializing in the protection of the elderly, it is emphasized to shift social awareness of elder abuse, strengthen reporting consciousness, and establish a network between related institutions.
- Related to improvement of awareness of elderly human rights and spread of filial piety culture, it was suggested to improve the quality of education, arrange guidance assistants, diversify performance contents, and specify measures to meet the purpose and goal of the senior citizen event.

- 4 Area for support of health and care services
  - For the two detailed plans for health promotion for the elderly, the visiting health care service was evaluated as excellent.
  - In the health center operation, it was proposed such as the introduction of a doctor system for the elderly and the operation of a smart senior citizen center for health care services.
  - In relation to visiting health care services, the operation of cognitive enhancement programs, the provision and promotion of comprehensive dementia prevention services, the strengthening of community links, and the introduction of visiting medical buses should review the understanding of the current status of establishing a medical health system in the community and the feasibility of policies.
  - In the comprehensive results of the six detailed plans for establishing dementia infrastructure and providing long-term care services, expansion of dementia-specific care facilities was evaluated as very excellent, and the operation of dementia safety center was evaluated as excellent.
  - The construction of specialized elderly complex facilities should reflect the mid—to long—term development plan of local governments. In relation to expansion of dementia—specific care facilities, it is required to provide a national responsibility system for long—term dementia care and a comfortable care environment in connection with the expansion of dementia—only nursing facilities.
  - In the operation of the dementia relief center, it is proposed to apply voucher cards, train professionals, conduct early checkups, and expand dementia relief hospitals.
  - The expansion of national and public long-term care institutions and the reduction of self-burden should be approached from a long-term perspective.
  - In detailed plans of support for age-friendly industry, the operation of the age-friendly industry support center was evaluated as insufficient, and the publicity is important. The development of dementia reserve technology was evaluated as very excellent, and the development of dementia prevention education programs was proposed.

#### ⑤ Area for improvement of living environment

- Six detailed plans for improving transportation convenience and safety for the elderly were evaluated as excellent overall, but the expansion of senior protection zones was evaluated as insufficient.
- Four detailed plans related to improving the living space environment were evaluated as generally excellent.
- It was proposed to raise incentives for voluntary return of elderly driver's license, expand the voice system for barrier-free stops, and install caring bus stops.
- In the case of low-floor buses, it was proposed to expand the number of operations, routes, and seats, support taxis for transportation of the vulnerable in traffic, and develop a portable emergency call button.
