Firstly, I would like to give you brief information on our city. Bornova, as one of the oldest local authorities of Turkey established in 1881 within the Province of Izmir, is located in the western coast of Turkey. Bornova is the cradle of many civilizations that conserves the rich history of 8500 years, where it is believed that Homer, the world-famous author of epic poems of Iliad and Odyssey had lived. Its rich historical background makes Bornova not only Izmir's but also all Aegean Region's oldest settlement center.
