## Re: BCP Council - Commitment to Age Friendly Communities

BCP Council aspires to lead and shape one of the best coastal places in the world in which to live, work, invest and play. We recognise that promoting good health and well-being within our communities plays a fundamental part in achieving that aim. BCP Council is therefore committed to joining the World Health Organisation's global network of Age-friendly communities.

Out of a population of 400,196, just under 22% are aged 65 and over, with this figure set to rise to 40% by 2040. Older residents are the foundation of our vibrant communities and as employees, volunteers, and active citizens, they bring a lifetime of skills and wealth of experience to Bournemouth, Christchurch and Poole.

Our new Corporate Strategy and Local Plan, built on the views from the public consultation has the vision of a place "where people, nature, coast and towns come together in sustainable, safe and healthy communities," with two key priorities and a set of ambitions for each:

- a) Our People and Communities everyone leads a fulfilled life, maximising opportunity for all.

- We have already adopted an Asset Based Community Development approach to our work, and we value the skills and capacity all community members will be able to offer to help achieve Age-friendly community status.
- Emphasis will be on practical steps we want people to see tangible successes as a result of this initiative.
- We are looking forward to learning from fellow Age-friendly communities and sharing our practice.

We are committed to developing a community in which all people can add years to their life and life to their years.
