In Canada, the prevalence of current cigarette smoking has decreased statistically significantly among youth since 1994. In 2014-2015, 3.4% of students in grades 6 to 12 were current cigarette smokers, with 1.6% smoking daily and 1.9% smoking occasionally. The prevalence of current cigarette smoking (3.4%) among students in grades 6 to 12 decreased compared to 2012-2013 (4.5%).

In grades 6 to 12, the prevalence of past-30-day tobacco smoking (i.e. any smoked tobacco product) among males (11.2%) is statistically significantly greater than that of females (8.4%) (Table B16).

The prevalence of past 30 days smokeless tobacco use remains unchanged for both males (3.0%) and females (0.6%) (Table B16).

Among youth in grades 6 to 12, 3.8% reported past 30 day waterpipe use to smoke tobacco or herbal, unchanged from 2012-2013 (3.4%).

Statistics Canada does not collect information specifically on the number of workers involved in tobacco-growing.

Statistics Canada Census of Agriculture data indicates the number of tobacco farms in Canada in 2016 was 195. All of these farms were in the province of Ontario. This represents an increase of 38% from 2011 to 2016. It should be noted that the number of tobacco farms in 2011 had decreased 75% from the 565 tobacco farms in 2006 and decreased 87% from the 1082 tobacco farms reported in 2001. Tobacco farms represented 0.1% of the 193,492 total farms in Canada in 2016.

On January 1, 2015, the Ontario Ministry of Finance began its oversight of the raw leaf tobacco industry. In June 2017 they reported 219 licensed growers of tobacco in Ontario. This represents a decrease of 16% from the 260 reported in 2015.

According to the Ontario Ministry of Agriculture, Food and Rural Affairs, the total value of tobacco production in Ontario in 2014 was \$132,879,000. This represents 0.067% of Canada's GDP of \$CDN 1,990,183 million in 2014.

AS AT DECEMBER 31, 2017: Federal/Provincial/Territorial Statutes and Regulations and other information are available on each government's website. Tobacco products are taxed by both federal and provincial/territorial governments in Canada. At the federal level, the Excise Act, 2001 imposes an excise duty on tobacco products manufactured in Canada at the time manufacturers package them and on imported tobacco products at the time of importation. Structuring federal excise duty to apply at this early stage in the production and distribution process helps to protect the tobacco tax base. Following packaging or importation, the excise duty is embedded in the price of the product. Provincial/territorial tobacco taxes are consumption taxes that are imposed on the consumers who purchase tobacco products. The provinces/territories secure their tax base by requiring wholesalers to remit an amount equal to the tax when they supply the tobacco product to other dealers. The dealers then recover this amount from their customers when the tobacco products are sold. For tobacco products, the final consumer selling price includes the federal excise duty, provincial tobacco taxes, GST/HST or, where applicable, provincial sales taxes. Federal Excise Duties: Federal excise duties are applied on all tobacco products. Provincial/territorial tobacco taxes: Provincial/territorial tobacco tax rates are set by the respective province or territory. The provincial/terrirorial tobacco tax applies to tobacco products which are destined for sale in that particular jurisdiction. Value Added Tax: The Goods and Services Tax (GST) is levied on an ad valorem basis on most goods and services across Canada at the rate of 5%. Where a province/territory has chosen to harmonize its sales tax with the federal system, a Harmonized Sales Tax (HST) is levied on an ad valorem basis on most goods and services in that jurisdiction. Currently, HST may apply at 13% or 15%. Retail Sales Tax: A province/territory that has not harmonized with the federal value-added tax system may impose a retail sales tax on goods and services sold within its jurisdiction.

Overall tobacco prices have been increasing in Canada over the reporting period based on the fact that cigarettes make up 93% of the market (by value) and cigarette prices have been increasing. In the past two years cigarette prices have increased by 7%, smokeless tobacco prices have increased by 3% while cigar prices have remained steady. Tobacco prices have risen due to increases in several provincial excise tax rates as well as a strategy of increased pricing incorporated by the tobacco industry.

Canada's Federal Tobacco Control Strategy (FTCS) is led by Health Canada in partnership with Public Safety Canada, the Royal Canadian Mounted Police (RCMP), Canada Revenue Agency, Canada Border Services Agency, and the Public Health Agency of Canada.

Health Canada is responsible for administering and enforcing the Tobacco Act. This Act regulates the manufacture, sale, labelling and promotion of tobacco products. Health Canada also undertakes and promotes initiatives that reduce or prevent the negative health impacts associated with smoking. The FTCS is championed by the Tobacco Control Directorate (TCD) of the Healthy Environments and Consumer and Safety Branch within Health Canada.

The FTCS provides funding to the Canadian Revenue Agency, Canada Border Services Agency and the Royal Canadian Mounted Police to address illicit contraband tobacco and to ensure compliance with Canada's tobacco tax laws. Health Canada's demand reduction activities such as prevention and cessation initiatives complement the contraband control activities of these partners.

Canada places a strong emphasis on collaboration between the federal, provincial, territorial and municipal governments, as well as non-governmental organizations, tobacco control researchers, academics, and community organizations.

C116. Please provide a brief description of the progress made in implementing Article 5.1 and 5.2 (General obligations) in the past two years or since submission of your last report.

The Government of Canada addresses the public health issue of tobacco control through the Federal Tobacco Control Strategy (FTCS). Launched in 2001, the FTCS was designed as a comprehensive, integrated and sustained approach to achieving reductions in tobacco use.

The Government of Canada renewed the Federal Tobacco Control Strategy (FTCS) for five years in 2012.

The current phase of the FTCS has two objectives: to preserve the gains in tobacco control made since 2001 and to maintain the downward trend in smoking prevalence. Priorities include:

- Supporting the pan-Canadian quitline and web portal to help inform Canadians about the availability of cessation services, and to support provinces and territories (P/Ts) in their efforts to provide cessation services;
- ? on-Reserve First Nations and Inuit tobacco control initiatives;
- marketing, awareness and outreach campaign to encourage cessation;
- Dintroducing matched funding and pay-for-performance for chronic disease focused grants and contributions; and
- Continuing coordination and support for Canada's membership in the World Health Organization's Framework Convention on Tobacco Control (WHO-FCTC).

The current phase of the FTCS expires on March 31, 2018. Public consultations on the future of tobacco control were carried out in 2017 and steps are underway to renew the strategy.

Canada has a comprehensive tobacco control environment with responsibilities shared by multiple levels of government. In addition to federal initiatives, all provinces and territories (P/Ts) currently have tobacco control legislation in place, some with restrictions beyond those found in the federal Tobacco Act. For example, a number of Canada's provinces and territories have enacted legislation addressing electronic cigarettes. Rules on smoke-free spaces are generally the responsibility of P/T and municipal governments, with the exception of federal workplaces and federally regulated spaces, such as banks and commercial aircraft.

All P/Ts also have extensive tobacco control strategies in place. P/T spending on tobacco control is estimated to represent more than half of the total tobacco control expenditure in Canada. P/T roles in tobacco control and health care service delivery will be taken into consideration in the development of the next phase of the FTCS.

Recent federal initiatives on tobacco:

The federal government has implemented nearly all of the available measures recognized by the WHO as good practices in tobacco control.

Recent federal initiatives include:

Flavouring additives

• In 2009, Canada became the first country in the world to ban the use of certain additives, including flavours like chocolate and bubble gum in cigarettes, little cigars and blunt wraps that were making these tobacco products more appealing to youth.

• The Schedule to the Tobacco Act was amended in 2009 to further restrict the use of flavouring additives in additional cigar types that appeal to youth. Building on changes that came into force in 2009 and 2015, which banned the use of certain additives, including flavours like chocolate and bubble gum to make them less attractive to youth, the Government of Canada finalized amendment to the Tobacco Act in 2017 to ban the use of menthol in cigarettes, blunt wraps and most cigars sold on the Canadian market.

Graphic health warnings

- [In 2000, Canada became the first country in the world to require pictorial health warnings on tobacco packages. In 2011, Health Canada increased the size of the graphic health warning messages from 50% to 75% of the front and back of cigarette and little cigar packages. The messages also include the toll-free pan-Canadian quitline number and web address to inform smokers about the availability of cessation services.
- [Regulations to introduce a new rotation of graphic health warning messages are under development.

Advertising prohibitions:

• The advertising of tobacco products has been further restricted by prohibiting advertising in Canadian publications that are typically viewed by young persons. Provinces and territories have also taken action to ban tobacco retail displays. In the province of Quebec, in November, 2015, royal assent was granted for Bill n°44: An Act to bolster tobacco control. This act introduced restrictions unique to Quebec regarding the advertising of tobacco products by tobacco manufacturers/importers/wholesalers directed at retailers.

Increased outreach as part of the 2012-2017 FTCS renewal:

• [A marketing, awareness, and outreach campaign has been implemented with a focus on encouraging cessation behaviour for young adult smokers (\$4.8M over five years).

Contraband tobacco

• A new Criminal Code offence with mandatory penalties of imprisonment for repeat offenders was created in 2014 to combat the trafficking and cross-border smuggling of contraband tobacco. These illegal, lower-priced cigarettes fund criminality and undermine tax and public health measures put in place to reduce tobacco use.

Plain Packaging

Canada is committed to introduce plain packaging requirements for tobacco products.

Health Canada undertook consultations in 2016 with partners and stakeholders, including provinces and territories, on the development of a proposal for plain packaging. A bill to enable plain and standardized packaging of tobacco products was introduced in parliament in November, 2016.

Canada has reviewed the Article 5.3 Guidelines in relation to the Canadian policy, legal and constitutional context and has adopted administrative measures, such as Health Canada's policy of not partnering with the tobacco industry on tobacco control programming.

Lobbying at the federal level in Canada is regulated under the Lobbyist Registration Act. It is illegal for corporations of any kind to contribute to political campaigns for electoral purposes. Some provinces also regulate lobbying. Furthermore, the Lobbyist Registration Act introduced a requirement that consultant lobbyists (ie: tobacco related activities) file a return with the Commissioner of Lobbying if they communicate with a designated public office holder under certain conditions. This registry can be searched by anyone through a publicly-accessible website.

Health Canada continues to discuss the Article 5.3 Guidelines with its federal partner departments and with relevant departments of provincial/territorial governments who are collaborators in the Federal Tobacco Control Strategy (FTCS). Generally, in Canada the primary channels of communication between governments and the tobacco industry are limited to (i) technical discussions in regard to both health and tax-related regulations and (ii) litigation-related responses.

In Canada, many aspects of the tobacco industry's health policy, business and promotional activities are matters of public record. In addition, civil society organizations keep close track of tobacco industry activities and maintain web sites, publications etc. for this and related purposes. The tobacco industry must report to government on its research and promotional activities pursuant to Tobacco Reporting Regulations of the Tobacco Act. Public access to information about the tobacco industry which is reported to the government pursuant to these Regulations is governed by the Canadian Charter of Rights and Freedoms, Access to Information & Privacy Act, and the common law as it relates to confidential business information.

Canada continues to review the provisions of Article 5.3 of the FCTC in a Canadian context and has taken steps to inform other federal government departments of the commitment. Canada continues to work with sub-national levels of government to ensure that they are aware of Article 5.3. Canada's civil society also engages in monitoring and putting forward policies and recommendations that are useful in both federal and sub-national tobacco control activities. In Alberta, in 2017, staff in the Ministry of Health were directed that any and all interaction with the tobacco industry must comply with Article 5.3. Interaction with industry is limited only to those meetings that are absolutely necessary to regulate the industry.

Health Canada recognizes the importance of Article 5.3 and, as such, now requires participants in consultation processes to declare perceived or actual conflicts of interest in making their submissions.

Canada was in compliance with Article 6 at the time of ratification. Canada's sub national authorities maintain price and tax measures within their respective jurisdictions and make progress in implementing Article 6.

Canada adjusted the excise duty on cigarettes and other tobacco products in 2014 to account for inflation since 2002. Rates increased from \$0.425 per 5 cigarettes to \$0.52575 per 5 cigarettes, resulting in an increase of \$4.03 per carton of 200 cigarettes. Since the last submission, federal excise duty rates on tobacco products increased in March 2017 (e.g., by \$0.53 per carton of 200 cigarettes) and February 2018 (e.g., by \$2.29 per carton of 200 cigarettes). The March 2017 increase maintained the intended tax burden of the manufacturers' surtax on tobacco products following its repeal.

To ensure that they retain their real value in the future, federal excise duty rates are indexed to Canada's Consumer Price Index and will be automatically adjusted accordingly every five years, starting in 2019.

Canada has comprehensive smoke-free legislation in public workplaces, primarily governed through sub-national jurisdictions. Recognizing that over 98% of indoor workplaces in Canada are smoke-free, there do exist, in a limited number of jurisdictions, provisions for tightly regulated designated smoking rooms in indoor workplaces.

National and sub-national jurisdictions provide for complete smoking bans in public transportation. A number of jurisdictions have implemented smoking bans in private vehicles where children are present. (The majority of jurisdictions identify children as under 16.)

Canada has virtually eliminated smoking in all indoor public places with the exception of group living facilities and specified hotel rooms. The number of designated smoking rooms has been drastically reduced.

There have been extensive developments in implementing Article 8. Comprehensive smoke-free legislation has been passed in all sub-national jurisdictions and numerous municipalities in Canada have adopted bylaws or policies to prohibit smoking in public places such as patios, play grounds and parks.

For example, as of Nov. 26, 2017, all colleges (CEGEP), universities and hospitals in Quebec were required by provincial legislation to adopt a policy regarding smoking on their grounds. While they need not adopt a 100% smoke-free outdoor policy, at least one has opted to do so.

Manitoba became the first province to ban smoking on playgrounds and beaches of provincial parks as of July 2014.

The 2015 Ontario Budget committed to addressing contraband tobacco through a balanced approach of partnership and enforcement, including ensuring better coordination between inspections conducted by Public Health Units under the Smoke-Free Ontario Act and inspections conducted by the Ministry of Finance under the Tobacco Tax Act. Cross-designating tobacco inspectors under each Act would optimize the effectiveness of compliance efforts and enhance the oversight of tobacco retailers. The pilot planning launched in early 2016.

In 2017, Canada amended the Tobacco Act to prohibit the use of menthol in cigarettes, blunt warps and most cigars.

In 2015, Canada amended the Tobacco Act to prohibit the use of appealing additives including flavours in additional types of cigars (weighing more than 1.4 g but not more than 6 g and cigars with tipping paper or a wrapper with a straight seam). The amendment was in response to the introduction of new flavoured cigars to the Canadian market. Additives that impart a wine, port, whisky or rum flavours were exempted in certain cigars.

On May 31, 2015 Nova Scotia became the first jurisdiction in the world to implement legislation banning the sale of menthol flavoured tobacco as part of a broader flavoured tobacco ban. Many other provinces have since implemented bans on flavoured products.

In 2009, Canada amended its Tobacco Act to prohibit the use of additives in cigarettes, little cigars and blunt wraps that contribute to make these products more attractive to youth. The prohibited additives are listed in a Schedule annexed to the Act. This list includes most flavouring preparations, spices, seasonings and herbs, sugars and sweeteners, vitamins and mineral nutrients, fruits and vegetables, essential fatty acids, and other additives. Menthol additives were excluded from the list of prohibited additives.

In 2005, Canada enacted the Cigarette Ignition Propensity Regulations, to require all cigarettes manufactured or imported for sale in Canada have reduced their likelihood of igniting upholstered furniture, mattresses and bedding. As per the regulations cigarettes must meet a standard that they must burn their full length no more than 25% of the time when tested using ASTM International method E2187-04; Standard Test Method for Measuring the Ignition Strength of Cigarettes.

In 2000, Canada enacted the Tobacco Reporting Regulations that set out the requirements for the reporting of information on the sales, manufacturing processes, ingredients, toxic constituents, toxic emissions of tobacco products sold in Canada, as well as research activities and promotional activities undertaken by tobacco manufacturers and importers.

The Tobacco Products Labelling Regulations (Cigarettes and Little Cigars) (TPLR-CLC) came into force in September 2011 and define new health-related labelling requirements for packages of cigarettes and little cigars intended for retail sale in Canada. The TPLR-CLC requires a health warning on at least 75% of the front and back panels, a qualitative toxic emissions statement on a side panel, and a health information message to be included either on the upper slide-flap, the exterior surface of the slide, or on a leaflet inserted in the package.

There are 16 different health warnings which are randomly available at point of sale locations. These will effectively rotate health warnings for cigarettes and little cigars.

Under the previous labelling requirements in the Tobacco Product Information Regulations, the toxic emissions statements displayed numerical values for six toxic emissions (tar, nicotine, carbon monoxide, formaldehyde, hydrogen cyanide and benzene). However, research conducted by Health Canada has shown that the numerical values were not clearly understood by some smokers and most had little idea what the range of numbers displayed for each chemical meant. Responsibility for education, communication, training and public awareness is shared between federal, provincial and territorial governments. The promotion of tobacco products in Canada is prohibited except as authorized by the Tobacco Act and its regulations. For example, tobacco products advertising is restricted to informative and brand-preference advertising on signs in adult-only locations such as in nightclubs, and in publications that are provided by mail and addressed to named adults. Furthermore, Canada has legislated a prohibition of lifestyle tobacco products advertising, including a total ban on sponsorship promotion by way of tobacco product-related brand names and manufacturers names.

The Promotion of Tobacco Products and Accessories Regulations (Prohibited Terms) came into force on September 22, 2011. They prohibit the use of the terms "light" and "mild", and variations thereof, on various tobacco products, their packaging, promotions, retail displays, as well as on tobacco accessories. These regulations apply to cigarettes, little cigars, cigarette tobacco, kreteks, bidis, tobacco sticks, cigarette papers, cigarette tubes and filters.

CancerCare Manitoba offers a Quit Smoking Program (QSP) to patients, their families and staff. The program includes an interdisciplinary clinic involving a nurse practitioner, nurse, social worker, pharmacist and pharmacy technician. The clinic's services help participants deal with the emotional and physical aspects of quitting smoking through a full range of supportive cessation treatments. Patients are screened, assessed, counsel'led and provided treatment of nicotine replacement and drug therapy at no cost to participants.

In January, 2016 up to \$1.0 million in new funding was provided for the implementation of a provincial nicotine replacement therapy (NRT) program that provides, free of charge, up to 8 weeks of NRT annually to eligible smokers looking to quit.

In Ontario, one of Canadas sub-national jurisdiction, new social marketing campaigns were implemented that targets adult regular smokers, and public education campaigns were implemented to advise the public about new smoking regulations. The 2015 Pan American and Parapan American Games were hosted in the City of Toronto and declared smoke-free and secondly, as a legacy component, the public was educated about the importance of smoke-free outdoor public spaces, particularly sporting fields.

The Public Health Agency of Canada (PHAC), a federal partner in Canadas Federal Tobacco Control Strategy, co-funded a number of tobacco projects designed to promote healthy living and to prevent chronic disease.

- Led by Manitoba Tobacco Reduction Alliance, the MANTRA project is establishing a certification program in tobacco addiction treatment at University of Manitoba and expanding Cancer Care Manitoba's Quit Smoking Program to seven outreach centres across the province. The MANTRA project complements the Canadian Partnership Against Cancer work to better integrate tobacco cessation into cancer care settings to improve patient access to healthcare professionals trained in tobacco addiction treatment. Partners for this project include Cancer Care Manitoba and Canadian Network for Respiratory Care. The project expects to reach 250 healthcare professionals.
- The Picking Up the PACE project led by the Centre for Addiction and Mental Health (CAMH) is enhancing the content of online training and implementing a peer coaching model with the aim of increasing the ability of healthcare professionals to offer interventions to address modifiable risk factors and improve smoking cessation outcomes. CAMH is partnering with the Medical Psychiatry Alliance in the development of the content that will be used with 350 healthcare providers in Ontario and will inform the online component of the Training Enhancement in Applied Cessation Counselling and Health (TEACH), an evidence-based program accredited by the University of Toronto Faculty of Medicine, professional regulatory bodies and the international Association for the Treatment of Tobacco Use and Dependence.
- Evidence in the field of tobacco control recognizes the relationship between tobacco cessation behaviour and other risk factors (e.g., unhealthy eating and inactivity) and identifies the need for chronic disease prevention strategies that address these interrelated risks. As a result a more recent, Canada-wide project called Run to Quit was launched, in partnership with the Canadian Cancer Society and the Running Room, to implement a tobacco cessation project while improving physical activity levels. Early results showed that 28% of participants had quit smoking and had successfully not smoked in six months. In addition, 43% of participants interviewed said they were still running, on average, three times a week. Participants also noted increased physical and mental wellbeing and confidence to quit smoking. These results are encouraging since rates for people trying to quit "cold turkey" average around 4%.

The Province of Alberta provides a number of resources which target under aged girls, young women, and pregnant women. These include the "Reproductive Years Guidelines" for health care providers which was designed to assist health care providers in supporting women and girls to stop or reduce the use of tobacco. They also provide a practical hands on guide entitled "Baby Steps Help Guide" for health care providers working with girls and women who use tobacco and tobacco-like products and are planning a pregnancy, are pregnant, or postpartum.

In order to protect youth from inducements to use tobacco products and the consequent dependence on them, the Government of Canada is further reducing the attractiveness of tobacco products by limiting the availability of menthol-flavoured tobacco products in Canada. To achieve this objective, the Government of Canada implemented in 2017 an Order Amending the Tobacco Act to prohibit the use of these menthol additives in the manufacture of cigarettes, blunt wraps and most cigars and their sale. This amendment will also mean that the prohibition on the promotion of menthol additives on tobacco product packaging will be applicable.

This program is now completed and the quota system has been removed.

At this time there are no tobacco specific federal only grant and contribution programs administered by Agriculture and Agri-Food Canada. Moreover, there are no cost-shared tobacco specific programs being delivered by provinces and territories under Canada's current national agriculture policy framework (Growing Forward 2), under which the federal-provincial-territorial governments share the costs of a wide range of agricultural programs.

In April 2012, JTI-Macdonald Corp. (JTI) and Imperial Tobacco Canada Ltd. (ITC) each launched constitutional challenges to the Tobacco Products Labelling Regulations (Cigarettes and Little Cigars). They asserted that the increase in size of health warning messages from 50 percent to 75 percent of the packages of tobacco products violates the corporations' right to freedom of expression under the Canadian Charter of Rights and Freedoms. No court dates have yet been scheduled.

All Canadian provinces and territories except Yukon have passed legislation to enable the pursuit of health care cost recovery actions against tobacco companies. All ten provinces have now launched actions seeking to recover health care costs from tobacco companies. Canada was named as a third party in three of these actions (i.e., British Columbia, New Brunswick and Ontario). The third party claims against Canada have been struck in the BC case (Supreme Court of Canada decision of 2011) and the New Brunswick case (New Brunswick Court of Queen's Bench decision of 2012) while in the Ontario Health Care Cost recovery, the three tobacco companies (JTI, ITC and RHB) discontinued their third party claims against Canada on June 19, 2014, August 28, 2014 and September 24, 2014, respectively.

In the Blais and Létourneau class actions, on November 12, 2012 the Quebec Court of Appeal struck out the defendants (JTIMacDonald Corp, Imperial Tobacco Canada Ltd and Rothmans, Benson & Hedges ('tobacco companies')) actions in warranty against Canada. As a result, Canada is no longer a party to the actions that were brought against the tobacco companies on behalf of approximately one million Quebecers suffering from tobacco-related diseases or addicted to nicotine. On June 9, 2015 the Honourable Justice Brian Riordan rendered his final judgement and granted the plaintiffs' claims in part and awarded damages totalling over \$15 billion. On October 27, 2015, the Court of Appeal granted the plaintiffs' motions for security pending the appeal of the June 9, 2015 decision of Justice Riordan. ITC and RBH were ordered to furnish just under \$1 billion in security. The Court of Appeal has not rendered its decision on the tobacco companies' appeal.

The tobacco industry has also brought multiple challenges to provincial legislation that prohibits the sale of menthol tobacco products. No court decisions have been released yet.

Canada recognizes the importance of a comprehensive approach to tobacco control and remains committed to the implementation of the provisions of the FCTC, subject to sovereign right.

Canada continues to implement the FCTC through the Federal Tobacco Control Strategy (FTCS).

The FTCS has helped reduce smoking rates to an all-time low. The comprehensive and collaborative approach of the Strategy will help to preserve the gains of the past decade and continue the downward trend in smoking to reduce tobacco related death and disease among Canadians.

To protect Canadians, especially young people, from the health consequences of tobacco use, Canada continues to focus on:

- preventing children and youth from starting to smoke;
- Phelping people to quit smoking; helping Canadians protect themselves from second-hand smoke; and
- Pregulating the manufacture, sale, labeling and promotion of tobacco products by administering the Tobacco Act.

The Government of Canada will continue to implement and enforce a strict regulatory environment that limits the tobacco industrys ability to use marketing to attract new smokers, and will continue to inform Canadians about the health hazards of smoking. This includes introducing plain packaging requirements for all tobacco products.

The 2012-17 Strategy places a specific emphasis on two groups with higher rates of smoking than most Canadians and on tobacco as a risk factor for serious disease. Specifically, Health Canada is committed to working with First Nations and Inuit partners to take steps to reduce and prevent commercial tobacco use, and has launched a marketing awareness and outreach campaign in partnership with the Canadian Cancer Society, using popular channels like Facebook and Twitter, to get young people talking together about smoking, about quitting, and remaining smoke-free.

Canada remains a strong and committed global partner to reduce tobacco use. Canada will continue to follow and promote best practices set out in the Framework Convention on Tobacco Control. Canada will also cooperate on cross-border efforts to stop trafficking of illegal tobacco products. Canada will continue to participate in multilateral negotiations to develop international quidelines and respond to requests to share our expertise in tobacco control.
