The trend of increase is significant especially among women daily smokers. This clearly signals that Women in Georgia are getting more and more dependent on tobacco products. Necessary steps are urgent to curtail tobacco industry marketing targeting women especially.

National Center for Disease Control and Public Health (NCDC) is the host institution of the Tobacco Control National Technical Focal Point. NCDC has a Tobacco Control Group which has been expanded within last two years, It comprised of 5 people fully dedicated to tobacco control.

The Committee was mandated to develop Tobacco Control National Strategy and Action Plan, both were approved by the Decrees of the Government in 2013. The tobacco control law amendment set is considered to be one of the most comprehensive in the region and is in full compliance to the WHO FCTC requirements. With the leadership of the Health and Social Affairs Committee of the Parliament of Georgia a Health Promotion and Prevention Council (HPPC) was created which is overseeing the overall preparation period of the implementation of new tobacco control legislation (the major provisions of the law enter into force from May 1, 2018)
