# Law No. (47) for the year 2008 Public Health Act/JORDAN

## Chapter XII

Protection of public health damage from smoking Article 52 --

Have the following words and phrases wherever mentioned in this chapter have the following meanings unless the context indicates otherwise: --

Tobacco products: products which consist, in whole or in part, from tobacco leaves as raw material and manufactured for use

For smoking, sucking, chewing or snuffing 0

Public place: hospitals, health centers, schools, cinemas, theaters, public libraries and museums

And government buildings, public and non-governmental organizations and the mass transportation of passengers and arrivals and departures lounges at airports

And indoor and lecture halls and any other place decided by the minister considered a public place and to publish its decision in the Official Gazette  ${\tt O}$ 

#### Article 53 --

 ${\tt A}$  - prohibits smoking of any tobacco products in public places, that he may make a decision of the Minister upon the recommendation of the Director

Health specialist to locate a special permit smoking in a public place subject to the public health and safety,

And the announcement of this place is clearly in a prominent place and in Arabic  $\boldsymbol{0}$ 

B - despite what is stated in paragraph (a) of this Article, prohibits smoking in nurseries and kindergartens in Public and private sectors, and by the relevant departments in cooperation with the Ministry to establish controls to ensure the implementation of this ban  $\ensuremath{\mathtt{0}}$

### Article 54 --

No person or a public or private, including the media print or display or publication of any declaration for the purposes of Any advertising of tobacco products or distribution of any brochure or tools or materials to identify him or the announcement of products

## Article 55 --

Prohibits any person as follows: --

 $\mbox{\bf A}$  - sale of tobacco products to anyone under the age of eighteen years  $\mbox{\bf 0}$ 

B - retail sale of cigarettes 0

C - The manufacture or import, distribution or sale of tobacco products imitators, including candy, cakes, games and tools Manufactured resemble any of the tobacco products  $\theta$ 

D - put machines to sell tobacco products 0

 $\ensuremath{\text{E}}$  - display any tobacco products except in accordance with a regulation issued for this purpose  $\ensuremath{\text{0}}$ 

#### Article 56 --

Both produce, import or marketed within the territory of the Kingdom of any of tobacco products to put in a visible place on the Cans or packages, of blood that is being marketed by tobacco products, shape or phrase, or both to be determined by the specification

## Chapter XV

Article 63 --

 ${\bf A}$  - punishable by imprisonment for not less than one week and not more than a month or a fine of not less than fifteen dinars and not more than

Twenty-five dinars each of the any of the following acts:

- ${\bf 1}$  Smoking any tobacco products in public places where smoking is prohibited  ${\bf 0}$
- 2 allow the administrator of the public place where smoking is prohibited to any person any of the smoking of tobacco products in which  $\mathbf{0}$
- 3 not the announcement of the ban on smoking in public place in accordance with the provisions of paragraph (c) of Article (53) of this Act 0
- 4 retail sale of cigarettes 0
- 5 Distribution of analogues of tobacco products or sold 0
- **B** punishable by imprisonment for not less than three months and not exceeding six months or a fine of not less than five hundred dinars and not more than
- A thousand each of the any of the following acts: --
- 1 no smoking of tobacco products in nurseries and kindergartens in the public and private sectors or to allow that 0
- 2 display any tobacco products contrary to the conditions determined by the Minister in the resolution enacted for this purpose 0
- 3 print or display or publication of any declaration for the purposes of advertising any tobacco products or distribution of any publication or tools or materials To identify him or that he is up for sale 0
- 4 development of machines to sell tobacco products 0
- 5 The manufacture or import tobacco products, imitators 0
- 6 production, import or marketing of any tobacco products within the territory of the Kingdom, contrary to the provisions of Article (56) of this Act 0
