In this case the “base” is the manufacturer’s price or retail price. If the tax is expressed as an amount (e.g. specific tax), the base of the tax is the volume (number of pieces or by weight) of goods that is taxed. For example, if a tax is US\$ 5 per 100 cigarettes, the amount of tax is US\$ 5 and the base of the tax is 100 cigarettes.

It provides policy orientation regarding tobacco control and oversees the implementation of the National Action Plan on Tobacco Control and the new FCTC-compliant tobacco legislation of 2008. Three focal persons for tobacco control (two technicians and one administrator) have been appointed and belong to the Ministry of Health.

	<p>The National Action Plan on Tobacco Control 2008-2012 provides the blueprint for a comprehensive, sustained and concerted action on tobacco control in Mauritius. Its implementation started in early 2009 and is being pursued. Some actions undertaken are: amendment of the 1999 tobacco legislation to make it FCTC-compliant, increased information and education, training of teachers and health personnel, improved surveillance and evaluation.</p>
