Last available data on smoking prevalence is 3rd STEPS survey in 2013. Next survey is planned to be conducted in 2018. Standardized prevalence of smoking in the study population in 2013 was 27.1% (95%Cl 25.2-29), which is nearly the same with the corresponding rate in 2009 (27.7%; 95%Cl 26.0-29.4) with no statistically significant difference. Similarly, there was no statistically significant difference in gender distribution of current smokers between the two surveys. In other words, there is no significant decrease in smoking.
