The most notable decreases were observed in the age groups 25-34 (53.1% in 1998 to 41.9% in 2003), 35-44 (58.7% to 44.2%) and 55-64 (46.9% to 35.2%). Smaller decreases were observed in the age groups 15-24 and 44-54.</p> <p>For females, current smoking has risen in the youngest age group (15-24) from 5.6% in 1998 to 7.0% in 2003. For age groups from 25 to 54 current smoking has decreased slightly. In age group 55-64, current smoking has increased from 10.7% in 1998 to 14.0% in 2003.</p>
