	Current smoker: someone who answered "yes" to the question "do you smoke cigarettes at all nowadays?"
2.1.1.5	Please provide a brief explanation of the trend in smoking prevalence in the adult population in the past two years or since submission of your last report.
	<p>In 2006, Azerbaijan implemented Demographic and Health Survey (AzDHS). Data from this show that smoking is common among men aged 15-49, with about half of them reporting that they are smokers. Among current smokers, over 90 percent reported that they smoked 10 or more cigarettes during the past 24 hours. There is no significant difference in smoking patterns between urban and rural men. The likelihood that a man smokes increases with age. An interesting pattern is observed between smoking and the level of education. Smoking is less prevalent among males with higher and basic secondary education (about 41 percent), while men with a secondary specialized education smoke more frequently than other men (60 percent).</p> <p>One of the objectives of the 2006 AzDHS was to provide population-based data on cardiovascular risk factors, e.g., hypertension and smoking, to complement data available from other sources. Hypertension is slightly higher among men who smoke than men who do not smoke (19 percent and 14 percent, respectively). According to the WHO, as many as 20 percent of all deaths among middle-aged men in Azerbaijan in the early 1990s were attributable to tobacco use (WHO, 1997; Peto et al., 1994).</p>

	<p>Cigarettes in Azerbaijan is competitive with legal brands struggling to compete with smuggled goods. Eight companies import cigarettes for sale in Azerbaijan, and face high customs tax payments. British American Tobacco Plc is the leading imported cigarette player in Azerbaijan, thanks to its long-standing presence, and well-known and popular brands, Kent, Pall Mall, Yava, Dunhill, Vogue, Viceroy and the recently re-launched, Lucky Strike brand. The company constantly endeavours to increase its volume share by introducing attractive new updates of existing brands, mainly Kent.</p> <p>Although cigarettes is led by giant domestic enterprise European-Tobacco Baku JSC, those companies operating imported brands are striving to further increase their share. There are no domestic producers of cigars or smoking tobacco in Azerbaijan.</p>

If the tax is expressed as a percentage (e.g. ad valorem tax), the base of the tax is the actual value of the good that is taxed; for example, 45% of the manufacturer's price, 30% of the retail price. In this case the "base" is the manufacturer's price or retail price. If the tax is expressed as an amount (e.g. specific tax), the base of the tax is the volume (number of pieces or by weight) of goods that is taxed. For example, if a tax is US\$ 5 per 100 cigarettes, the amount of tax is US\$ 5 and the base of the tax is 100 cigarettes.
