Smoking is related with 10.1% of all deaths in Georgia. Smoking is responsible for 22.4% of deaths among all deaths caused by tobacco related diseases in age group 35 and older. C227a. Banning tobacco smoking in indoor workplaces

According to the national tobacco control law there is a provision of partial ban of smoking in governmental facilities but due to the complicated and not flexible administrative mechanisms which do not envisage precisely the accountability to the authorities who have to be responsible for the implementation the law is not enforced expect some voluntary initiatives. Private workplaces are not bound by law to be smokefree or partially smokefree.

C227b. Banning tobacco smoking in public transport

According to the national tobacco control law there is a provision of complete ban of smoking in public transport such as airplanes, buses, mini-buses, metro etc. in the trains and ferries there have to be specially designated areas for smoking and there is no provision at all for private taxis. Weak administrative mechanisms do not allow full enforcement of this provision and there are cases of violation in the public transportation from the drivers of buses and mini buses.

In indoor public places such as theaters, cinemas and other cultural facilities there have to be specially designated smoking areas but weak administrative mechanisms do not allow full enforcement of this law except of some voluntary cases. in hospitality sector facilities such as restaurants, bars, cafes the according the national tobacco control law there has to be 50% of division of space into smoking and non-smoking areas but because of the weak administrative mechanisms it is not fully enforced except of some voluntary cases where even full smoking ban is implemented by the owners of the facilities.

There is a requirement for the amount of the nicotine and other substances to be depicted on the packaging of tobacco products, which is not in line with the WHO FCTC implementation guidelines.

According to the amendment project to the Tobacco Control Law this requirement will no longer be in place but the law has not been passed in the Parliament yet.

Since 2010 following the amendments to existing tobacco control law all manufactured tobacco product packages include textual health warnings on the space of 30% of the whole surface which are required to be rotated periodically.

There is no obligation to depict graphic health warnings on the manufactured tobacco products packages. there are 9 pictorials which Ministry of health adopted from the EU in 2009 and usage of which was suggested according to the Act of the Minister of Health since 2014 and according to the Government Decree from 2014, but depiction of pictorial health warnings is still only voluntary.

according to the amendment package to current legislation the provision to require the increase of health warnings up to 50% of the whole surface of manufactured tobacco products packages and to make depiction of pictorial health warnings mandatory but the amendment package is not passed in the Parliament yet.
