Articles of the law

Article 1 -

This is called the law (the law control the behavior of the events of the year 2006) and shall be effective after thirty days from the date of its publication in the Official Gazette.

Article 2 -

A - shall have the following words and phrases, wherever mentioned in this Law have the following meanings unless the context indicates

Otherwise: -

Minister: Minister of the Interior.

Administrative Governor: Governor or the holder or the Director of the judiciary. Committee: Committee for monitoring the behavior of events, the problem under the provisions of this law.

Event: Any person who has completed seventh not yet eighteen years of age, whether male or female.

Begging: for solicitation or request that the charity event by either him or to others, was a roving or sitting in a public place,

Citing to his wounds, or by displaying a handicap or to resort to any other means to this end.

Tobacco: Cigarettes, cigars and (Altmbak) and any tobacco products in any way. B - for the purposes of this Law:

- 1 means drugs and psychotropic substances, wherever mentioned in this law the meaning of each phrase (article narcotic
-) And Gateway (psychotropic substances) contained in the Law on Narcotic Drugs and Psychotropic Substances in force 0
- 2 The term (volatile substances) contained in this law, the material shall have to use the event case of damage

Regards to what is caused by drugs and psychotropic substances of addiction, such as the (thinner) and (Alajo).

Article 3 -

A - Subject to the provisions of any other legislation in force, especially the Penal

Code and the law of narcotic drugs and psychotropic substances, are prohibited Event as follows: -

- 1 buy tobacco or alcohol or narcotic substances, psychotropic substances or volatile substances from any point of either him or the other.
- 2 or water pipe smoking tobacco or alcohol or narcotic substances, psychotropic substances or volatile substances.
- 3 frequenting nightclubs or bars.
- 4 begging.
- B No person shall assign any event to purchase tobacco or alcohol, regardless or private prescription narcotic substances, psychotropic substances, whether Him or to others or exploit any event for use in begging.

Article 4 -

A - prohibits, under pain of criminal liability, the following acts: -

- 1 the sale of tobacco or alcohol or narcotic substances, psychotropic substances for the event, even if it is under prescription in respect of articles Narcotic drugs and psychotropic substances, including the ban sale of volatile substances.
- 2 Allow for the event well worth enjoying nightclubs or bars.
- 3 Providing alcohol or water pipe for the event in cafes, restaurants and similar places provided by the 0
- 4 Use the event in the begging 0
- B criminal responsibility referred to in paragraph (a) of this article to anyone who violates its provisions according to the following: -
- 1 owner of the place of sale of tobacco or alcohol or volatile substances or responsible for the administration or seller 0
- 2 the pharmacist in charge of the pharmacy that sold drugs and psychotropic substances 0
- 3 owner of the nightclub or bar, or responsible for the management of either one or two user 0
- 4 the owner of the cafe or restaurant or any other provider of alcohol or water pipe or responsible for the management of any of them or the user.
- 5 the person who used the event in the begging 0
- C is committed to each of the items mentioned in (1) and (2) and (3) and (4) of paragraph (b) of this Article status declaration visible at the entrance The place of its kind showing the ban imposed by the provisions of this law.

Article 5 -

For the purposes of this Act, the responsible for the supervision of any shop selling tobacco or alcohol or pharmacist responsible for the material exchange Narcotic drugs and psychotropic substances or any other responsible for the management of any nightclub or bar or cafe or restaurant management, and make sure Mathlhma

From a lifetime of frequent any of them if the situation clearly indicates that he has not completed eighteen years and that access to the civil status card Its own or any other official document to prove his age.

Article 6 -

Formed in each province of the Commission or more is called (to monitor the behavior of the events) and the recipe for its members with regard to the law enforcement

The application of the provisions of this law, and determine the composition and method of the agencies represented and of its functions and exercise its powers and organization of

Meetings and take the recommendations under the regulation issued pursuant to the provisions of this law.

Article 7 -

A - punishable event that violates any provision of this law a fine of twenty dinars, and doubled the fine in case

Repeated violation of the 0

B - If the beggar and the event violates any provision of this law shall apply the penalties provided for in paragraph (2) of Article

(32) of the Code of the events of 1968 or any penalty be replaced by 0

Article 8 -

A - Notwithstanding the provisions of any other legislation, shall be punished by imprisonment for a period not exceeding six months or a fine not exceeding five hundred dinars

Or both penalties Any person who commits any of the following offenses: -

- 1 the event sold tobacco or alcoholism or volatile materials or the cost of purchase or exchange any of them have a private prescription narcotic substances, psychotropic substances.
- 2 for the event were allowed to enter nightclubs or bars.
- 3 feet for the event alcohol or water pipe.
- 4 Use the event in the begging will be confiscated and the money that had been seized as a result of begging.
- B the penalty is doubled if the repeated commission of any of the offenses set forth in paragraph (a) of this Article.

Article 9 -

Notwithstanding the provisions of any other legislation, the governor of the competent administrative closure of the shop or pub or cafe or restaurant, which commits

Owner or the administrator or user to manage it contrary to the provisions of this law in the event of repetition of committing any of these offenses. For a period not less than one month nor more than three months either nightclub shall be closed permanently.

Article 10 -

Apply to any offense committed in violation of the provisions of this law any more severe penalty stipulated in any other law to take effect.

Article 11 -

The Minister shall issue the necessary instructions to implement the provisions of this Act, including the following: -

- A? The procedures to be adhered to by the owners of stores that sell tobacco, alcohol and volatile substances shops and nightclubs
- , Bars, cafes, restaurants and other than covered by the provisions of this law and those responsible for management.
- B? How to organize and edit control violations are contrary to the provisions of this law.
- C? Materials and dispose of the money that had been seized.

Article 12 -

Prime Minister and Ministers shall be responsible for the implementation of the provisions of this law.
