To protect the tax rate against inflation the tobacco excise is indexed against the Consumer Price Index (CPI), the adjustment being made on 1 January each year. In addition, the excise on tobacco products has increased by 10 percent every year 2010 - 2016 (on 28 April 2010 and 1 January every year since).

The tobacco tax increased by 11.09% on all tobacco products (10% legislated plus 1.09% CPI adjustment on 1 January 2015 and on all tobacco products (10% legislated plus 0.3 % CPI adjustment on 1 January 2016

Tax excise rates have increased on 1 January 2015 and 1 January 2016 as outlined above.

Projects conducted under the Pathway to Smokefree New Zealand 2025 Innovation Fund (\$5 million / year) have been conducted and are being evaluated.

A Bill to introduce standardised ("plain") packaging is before Parliament.

Under the Government Health Target "Better Health for smokers to quit" over 95% of smokers admitted to hospital are provided with smoking cessation advice, as are over 90% of smokers who receive primary health care and 90% of pregnant women who smoke when receiving maternity care.

From 1 November 2014 the duty-free allowance fell from 200 cigarettes to 50 cigarettes. In addition, and also from 1 November 2014, tobacco was removed from the gift concession that currently allows gifts sent from overseas to be free of duty and GST when they arrive in New Zealand, providing they exceed no more than \$110 in total value. This meant that all gifts of tobacco products sent to New Zealand are now subject to excise duty and GST.

Prisons have been smoke-free since 2011.

Pacific Island countries and territories have been supported by the New Zealand government through the New Zealand Aid Programme. The most significant contribution is the 14 country Pacific NCD Initiative (2014-17). Funds and technical support will be directed through the WHO Division of Pacific Technical Support in Suva towards ensuring a 15% reduction in adult cardio-vascular disease risk by 2018 and a 10% reduction in adult tobacco use by 2018. In 14 Pacific countries, this includes support to national tobacco control initiatives. In addition, New Zealand has provided support to a mobile-health intervention to reduce tobacco use in Samoa and American Samoa (2014-2016). This support will develop and evaluate an accessible, affordable and culturally relevant text message support for people who want to quit smoking.

The laws governing tobacco and medicines are imperfect for regulating electronic cigarettes. Non-nicotine containing e-cigarettes can be sold legally. Nicotine e-cigarettes are sold illegally on the local market. Work is being undertaken to clarify the situation.
