Since the implementation of Republic Act No. 10351 otherwise known as the Sin Tax Law which started in January 2013, taxation for tobacco products has dramatically increased. This trend in taxation for tobacco products will continue to increase until 2017 when it becomes unitary. After 2017, there will be a continuous increase in taxation by 4% per year.

For the Sin Tax Law Incremental Revenue for Health, Php 14.22 billion pesos was earmarked in 2013, Php 9.12 billion pesos in 2014 and Php 33.74 billion pesos in 2015.

The Department of Health (DOH) designated the Health Promotion and Communication Service (HPCS) as the National Tobacco Control Coordinating Office (NTCCO) through Department Order # 2011-0029 dated February 7, 2011. The HPCS served as the Tobacco Control Unit with its HPCS Director as the focal point person for tobacco control. Selected staff from the HPCS provided about 25% - 75% of their full time employment to tobacco control. In addition, three (3) full time staff were hired to implement the Bloomberg Initiative Project RIOC-401B. Some departments of the DOH assign staff from their unit to work on tobacco control based on demand. NTCCO activities were financed from the grant provided by the International Union Against Tuberculosis and Lung Disease (The Union) with counterpart funds from the HPCS.

The DOH has a National Tobacco Control strategy document for 2011-2016. This document outlines the goals and strategies to implement tobacco control in the country. 13 Sector-wide Anti-Tobacco (SWAT) Sub-committees were organized to coordinate activities related to the implementation of FCTC Articles 5.3, 6,8,9,10,11,12,13,14,15,17,18 and 20.

At the sub-national levels, Regional Tobacco Control Networks headed by the Health Promotion Coordinators of the Regional Health Offices coordinated and implemented tobacco control activities in their respective regions.

In December 14, 2015, the management of the National Tobacco Control Program was transferred from the Health Promotion and Communication Service (HPCS) to the Disease Prevention and Control Bureau (DPCB) by virtue of Department Order 2015-0270. As of the last report in 2014, seven (7) out of thirteen (13) SWAT sub-committees were active, with the Sub-committee on Article 5.3 as the most active. The Sub-committee on Article 5.3 is led by the Philippine Civil Service Commission (CSC), with funding support from The Union.

The Department of Health and the Civil Service Commission (CSC) issued the Joint Memorandum Circular (JMC) No. 2010-01 dated June 26, 2010 on "Protection of the Bureaucracy Against Tobacco Industry Interference". The JMC adopted the guidelines set forth by the WHO-FCTC in implementing Article 5.3. A SWAT Sub-committee on Article 5.3 was established headed by the Civil Service Commission to coordinate efforts in protecting public health policies from tobacco industry interests. Tobacco Industry interference is monitored and reported to the Sub-committee.

C124. Please provide a brief description of the progress made in implementing Article 5.3 in the past two years or since submission of your last report.

To date, a total of 216 orientations on the JMC had been conducted by the Civil Service Commission (CSC), Department of Health (DOH), Framework Convention Alliance Philippines (FCAP) and Health Justice (HJ) to various government officials, administrative officers, legal officers and other employees. Several orientations had also been given by the CSC and DOH Regional Offices to their respective constituents and other regional agencies. A total of 70 agencies both at the national, regional and local government level had adopted the JMC policy in their respective agencies.

The Article 5.3 Sub-committee led by the CSC continues to hold regular meetings to act on reported violations of the JMC. The Sub-committee continues to monitor and hear reports on violations. The online reporting mechanism for complaints against violations of the JMC, which is coursed through the CSC Help Desk: Contact Center ng Bayan, remains to be available for reporting from the public.

Moreover, the Philippines through the CSC was also designated as a Technical Assistance provider for Article 5.3 to other countries under the South-South and Triangular and Cooperation Meeting.

The national law on Republic Act 9211 or the Tobacco Regulations Act provides a ban on selected public places, transport facilities, access restriction to minors, ban on advertising and promotions as well as printed health warnings. The law also allows for designated smoking areas within indoor workplaces and public places. The passage of the Graphic Health Warning law had recently required the use of pictures in cigarettes packs to warn consumers on the harmful effects of tobacco use.

Sub-national laws include ordinances issued by provinces, cities or municipalities. These are drafted by the local legislative council and implemented at localities administered either by the Provincial Governors, City/ Municipal Mayors and Barangay Captains. Local laws on tobacco control may be more stringent than the national law in view of the autonomy provided to local government units by the Local Government Code of 1991.

Administrative or Executive Orders refer to policy issuances by the national government agencies on tobacco control. Policy issuances are based on the authorities given by the law, by the President of the Philippines, international treaties or respective mandates of government agencies. Policies apply to all constituent offices at the regional and local levels which are administered by the agency. The policies guide actions of the government agency in the implementation of its mandate and functions related to tobacco control. Examples include the prohibition of smoking in government facilities, schools and public conveyances issued by the Civil Service Commission, Department of Education and Land Transportation Franchising and Regulatory Board, respectively.

Republic Act 9211 mandates the Inter-agency Committee on Tobacco as its implementing arm, provided with exclusive power to administer and implement provisions of the law. The Committee is headed by the Department of Trade and Industry (DTI) as Chairperson and the Department of Health (DOH) as Co-Chairperson. Members include the Department of Agriculture, Department of Justice, Department of Environment and Natural Resources, Department of Science and Technology, Department of Education, National Tobacco Administration, representative from the Tobacco Industry and a Non-government Organization. The Monitoring and Enforcement Guideline (MEG) of RA 9211 details the designation and functions of pilot agencies in the implementation of the law as well as the procedures in the filing of complaints, investigation and reporting. Violations have corresponding penalties under the law.

At the sub-national level, the Local Government Units (LGUs) may assign or deputize a specific task force to enforce the ordinance on tobacco control. The composition of the task force differs from each LGU, and may include but not be limited to the City/ Municipal Departments such as the City/ Municipal Health Office or City/ Municipal Environment and Natural Resources Office, the Local Police Force, Sanitary Inspectors or Traffic Enforcers. Local Tobacco Control Councils may be created to serve as the implementation arm of the LGU. Most of the local enforcers at the sub-national level are authorized to issue citation tickets for violation of their local ordinances. Similarly, violations have corresponding penalties.

Under administrative and executive order, enforcement is assigned to a specific office within the agency, tasked to regulate or implement the policy. Monitoring and enforcement guidelines are issued to set out the procedures.

C227a. Banning tobacco smoking in indoor workplaces

For private indoor workplaces, partial ban to tobacco smoking is enforced. The enforcement of a no smoking policy is highly depended on the individual policies or health programs enforced by each company.

C227b. Banning tobacco smoking in public transport

Tobacco smoking is prohibited in all public conveyances including airplanes, buses, taxis, jeepney and tricycles. Not included in the ban are ferries and private motor vehicles.

C227c. Banning tobacco smoking in indoor public places

Government buildings, health care facilities, as well as educational institutions and universities are prohibited from smoking tobacco. These prohibitions are covered by the policies from the Department of Health and Department of Education. However, shopping malls, pubs and bars, nightclubs, and restaurants only have partial banks. Policies depend on the company and compliance to city/ municipal ordinances.

At the sub-national level, there is an increasing number of Local Government Units with local ordinances on 100% smoke free environments. Efforts are being made to ensure that local ordinances are consistent with FCTC provisions. The implementation of the Red Orchid Award (ROA) served as an incentive for LGUs to pursue a 100% smoke free environment in their localities. Local ordinances consistent with the FCTC guidelines were made criteria for selection of the winning LGUs in the ROA. The DOH was able to identify LGUs with good practices on 100% smoke free environment through the ROA. As a result, a network of LGUs leading in the implementation of 100% smoke free environment was organized through the Smoke Free Cities Asean Network (SCAN).

In 2015, the Department of Health conducted a TAPS monitoring in 16 selected municipalities and cities. Results indicated good practices among selected LGUs implementing a comprehensive ban on TAPS. However, TAPS were also found to be rampant in points of sale and other localities such as variety stores and restaurants that advertise tobacco products through the use of posters or other colaterals. Comprehensive TAPS ban was made a criteria in the selection of ROA winners.

To counter illicit cigarette activities, the Bureau of Internal Revenue (BIR) has implemented various measures such as the affixture of internal revenue stamps with security features on imported and locally manufactured cigarettes and the use of Internal Revenue Stamps Integrated System (IRSIS) for the ordering, distribution and monitoring capability that will ensure the collection of correct excise tax on cigarette products as prescribed under Revenue Regulations No. 7-2014. Another measure is the institutionalization of the Electronic Official Registry Book (e-ORB) on tobacco products which is an automated facility that allows excise taxpayers to electronically submit the ORBs for monitoring and reconciliation purposes with the end view of uncovering possible discrepancies on declarations of removals of cigarette manufacturers. Also implemented is the round the clock (24/7) monitoring of Revenue Officers on Premise (ROOPs) on cigarette manufacturer's plant sites and the installation of Close Circuit Camera (CCTV) to close monitor the operations of one major cigarette manufacturer.

Sections 7 to 12 of the Republic Act of 9211 (Tobacco Regulation Act of 2003) on Access Restrictions has prohibited the sale and distribution of tobacco products to minors, purchase of tobacco products from a minor, sale of tobacco products by a minor and for a minor to smoke tobacco products. Moreover, sale of tobacco products is prohibited within 100 meters of school perimeters as well as sale to minors by means of a vending machine or any self-service facility. The law also requires warning to minors about unlawful sale or distribution to minors of tobacco products at points of sale and need for age verification during purchase.

The Department of Education has issued policies to address sales of cigarettes to and by minors within the school such as school premises, school canteens and in the implementation of school activities. Policies are: Operating Guidelines on Canteen Management, 100% Smoke Free Environment, adoption and observance of related provisions of RA 9211 as well as the adoption and implementation of the Joint Memorandum Circular on Protecting the Bureaucracy Against Tobacco Industry Interference (Article 5.3).

The Metropolitan Manila Development Authority (MMDA) through their Balik Eskwela (Back to School) program conducts daily inspection of stores for display of tobacco products and warning to minors, within the 100% meter school perimeters in Metropolitan Manila. To date, 2,183 stationary stores and 780 ambulant vendors had been monitored by the MMDA for compliance to access restriction laws.

The Department of Education (DepEd) has initiated the development of a Comprehensive Policy and Guidelines on Tobacco Control to address not only the problem of smoking in schools and Department premises but also address tobacco industry interference in DepEd implementation policies in the guise of Corporate Social Responsibility (CSR). The DepEd policy includes education and information on harmful effects of tobacco use and exposure to second hand smoke as well as tobacco industry interference tactics; and guidelines to access effective cessation intervention services. It also includes guidelines on the enforcement of absolute smoking bans, access restrictions to minors, ban on tobacco outdoor advertisements, promotion and sponsorship as well as school donations received through the CSR activities of tobacco companies.

A team composed of representatives from the Department of Agriculture, Department of Agrarian Reform, Department of Labor and Employment and the Department of Health, including representatives from the Regional Health Office and Agricultural Office had been organized to travel to Brazil to study their Alternative Livelihood Program. It is expected that the Philippine team will develop a proposed country specific project on Alternative Livelihood for Tobacco Farmers.

Two project proposals were drafted for Malaysia and Mongolia on Article 6: Taxation. Another proposal was considered for Iran and Uruguay. The Philippines, together with the University of Capetown, South Africa and the World Lung Foundation were selected as technical experts. A proposal for information sharing on Party practices on Tobacco Industry Interference was also proposed with the Philippines identified as technical expert. Moreover, In collaboration with Brazil, technical assistance will be received by the Philippines on Article 17 Alternative Livelihood.
