

# Meetings with tobacco industry representatives

Article 5.3 of the WHO Framework Convention on Tobacco Control requires parties to the convention 'In setting and implementing their public health policies with respect to tobacco control ... to protect these policies from commercial and other vested interests of the tobacco industry in accordance with national law.'

As a Party to the treaty, New Zealand is required to observe complete transparency in its dealings with the tobacco industry (article 5.3). As part of meeting this requirement, the Ministry of Health maintains a public record of all of its meetings with tobacco organisations and their representatives. This practice has been in place since 2011; all records are below.
