The consequent "gift" or "blessing in disguise" of this is that I was forced to be a resourceful, independent, insightful, imaginative self - starter, with an ability to self-create early in life. I believe in the adage that "how you start has no bearing on how you will finish."

My education qualifications/ certificates obtained post matric which includes being awarded a Certificate in Real Estate Investing and Financing; Swiss Finance Institute, Geneva Switzerland (2005) and obtaining a PLD Certificate at Harvard University Business School (2006/7) all of which were self- funded are a testimony to this. I was invited to contribute towards the strategic development of numerous organizations and entities including but not limited to The Durban Chamber of Commerce and Industry (DCCI), The Durban Chamber Foundation, The Institute of Directors, Business Arts South Africa (BASA), The Market Theatre Foundation amongst others. The common denominator has been deep experience in Business, Arts, and Culture, Real Estate, Trade and Investment spanning over 20 years. The high watermark being a well- honed ability to combine the artistic excellence and skill with business skills to create a platform for strong and sustainable business. The contract endured for three years, and the festival became a national and global event materially contributing to the City of Durban's tiscus, economic multiplier exceeding R250Million.

In 2003, Gumbl Global, as part of a BEE consortium bought equity into Brait Private Equity, in an R R1, 5B transaction divested with healthy multiples In 2011. On the other hand, AmaGumbi Properties acquired and managed the valuable commercial real estate, The Chamber House Durban CBD, an asset held till 2011. I combined my entrepreneurial skills and accountability. I became actively involved in the Corporate Governance movement through the IOD as board member, member of the executive committee as well as Chairman of the KZN IoD Chapter. I was invited by the Centre for Corporate Governance in Africa, University of Stellenbosch Business School as part of the reference group of experts to review the design of a corporate governance metrics tool which sought to measure corporate governance performance of PIC Investee Companies listed on the JSE.

I was invited to joined the Market Theatre as a member of the Board in 2009. I became part of a team charged with reviving and repositioning the institution. This lead to my appointment as Chairman of the Board in 2012. The iconic Market Theatre is amongst the leading theaters and art institutions in the world. My role as Chairman was to oversee the turnaround strategy which would see the conversion the theater from protest theater to one of the leading theaters in the world alongside Broadway. Exercising stewardship of the institution together with a board comprising of 7 directors made of respected industry doyens like Dr. John Kani, Prof Zakes Mda and other captains of Industry has been most rewarding. The strategy has ensured organizational renewal and repositioning of artistic excellence and programming, drawing patronage of high caliber, diverse audience, the redevelopment of the New Town precinct catalyzing investment of more than R2bn in the precinct. Due to our sound stewardship of The Market Theatre, the Department of Arts and Culture gave us the task of Administrator of Windybrow Arts Centre. Within 36 months, we have turned it around the theater and repositioned it as a Pan African Community Theatre and a Business Unit of The Market Theatre Foundation. We continue to enjoy and Invest in global collaborations with the US Embassy, French Embassy MoU, Heads of Missions. Nelson Mandela Foundation.

I have served as Board member for 15 years, eight years of which I was an ordinary Board Member, followed by the position of Vice President 3 years and Deputy President for four years respectively. I have dealt with all spheres of government, created international and local strategic partnerships for the benefit of the chamber members. I have attended and presented papers at World Chamber Conferences in on various topics affecting the SMME sector:

In my capacity as Chairman of the SMME Committee:-

- I introduced a closed preferential procurement for members of the Chamber within private and state-owned companies a forerunner to enterprise development. Coordinate all SMME activities.
- A two-month work study in 2004 in Flanders, Belgium led to a long-lasting beneficial relationship with one of the respected Chambers in Belgium, the Voka Chamber, Antwerp. - Standard Bank / Durban Chamber Entrepreneur of the Year Award endured for seven (7) years
- Initiating, Planning and Participated in Inbound and Outbound Trade Missions In France, UK, India, USA, Malaysia, China, Hong Kong, Taiwan, Australia Brazil, Russia, Germany, Russia, Czech Republic, Swaziland, Mozamblque, Seychelles, Belgium identify trade opportunities while matchmaking with local business partners. Chairman of the Durban Chamber Foundation – Chairman (2005 – 2015)

- Developed and nurtured the ten (10) year relationship between the Durban Chamber Foundation and British American Tobacco of South Africa. BAT provided an R10m sponsorship during this period for the development of the SMME in KZN leading to approximately 2000 per annum SMME benefiting through the skills development program. The SMME Conference was anchored based on this sponsorship, later adopted by SEDA as the Best Practice Model for engagement with SMME
- We were part of the consortium for the R660m initial South African Global Fund recipients towards the fight against HIV/Aids. Durban Chamber Foundation and UKZN recipient of the initial Global Fund Funding to Sub-Saharan Africa to combat the spread of HIV / Alds. Working with an international team of funders and South African National Aids Council (SANAC) including Politicians / National Treasury Department. This funding was received long before the South African Government had formulated and adopted its roll out of anti-retroviral medication.

Chairman of Business Arts South Africa (BASA) (2011 - 2016)

From 2007 I was an ordinary Board member of BASA subsequently elevated to the position of Board Chairman in 2011. I have worked with some of the top banks in South Africa RMB, ABSA, and private collectors. My role has included building trust between the private sector and government leading to continued co- investment in Arts. The prevailing theme has been on how to keep the best of South African art within the country while at the same time it is being exhibited and showcased to be enjoyed by future generations.

Celebrate Durban 2002 - 2005

Conceptualized and project managed Celebrate Durban, a concept designed to bring social cohesion and patriotism for Durban and the forerunner to Durban's Tourism success of today. The approach was to involve Durban's sister cities in the US, New Orleans and Chicago which we had to visit to create meaningful partnerships.

Durban Vodacom Beach Africa (2003 -2005)

Contracted by eThekwini Municipality as project manager of what is dubbed as the World's Biggest Beach Festival. Through the provision of excellent programming of entertainment inbound tourism, provision of international sporting and surfing event, trade opportunities for small business, contracting with entertainment line- ups, negotiating broadcasting rights, liaison with established radio stations and TV; marketing and publicity of Durban as a prime tourism destination through the winter season.

Community Development Workers (CDW) for the Expanded Public Works Program (EPWP) on behalf of the Provincial Government KwaZulu-Natal (KZN) Launch (2005 -2006)

The project involved developing a blueprint for the Expanded Public Works Program to galvanize youth employment and participation in community development in Ugu District uThungulu, uMgungundlovu, eThekwinl, and KwaDukuza. I was charged with overseeing the development of community partnerships with the project as well as its successful launch. This allowed us to work with various communities and towards embracing government programs. We were working directly with the Program Office for CDW.

Installation of Amakhosi Department of COGTA (2005 – 2006/7)

Post-democratic rearrangement to restore traditional leadership as recognized by the constitution, I was appointed to consulting with various individual royal households, communities towards the installation of their heads through the Department of Local Government & Traditional Affairs for their participation.

Talk-Show Host with KZN Regional Commercial Radio Station iGagasi FM and Radio Commentary (2008 – 20011)

I served as host of a Current Affairs Program on a Regional radio station with a National Reach on International Economics, Political and Current Affairs. This opportunity, while drawing on my business and trade experience also strengthened my understanding of the Radio medium, its business model, programming and content delivery. Various print media have sought my expertise and economic understanding for commentary on economic trends and related topics, particularly a breakdown and review of the South African National Budget, as well as its impact on a variety of industries. A defining moment at the beginning of 2008 following the GFC (Global Financial Crisis) is that, to the dismay of many, my analysis resulted in my giving an economic projection that its Impact would abate only after 2018, enduring from "2008 – 2018" thus dubbing it "the lost decade." This analysis holds true and has proven correct to this day.

Department of Health KZN Project: Establishment of District Aids Council. HIV & Aids Awareness (2002 – 2007)

Our company was awarded a project to establish the district Alds Council around the province 11 District Municipalities. We played a supporting role in disseminating information on the treatment drive and debunking the myths surrounding the virus. We also did the communication plan for the HIV/Aids program throughout the province. We interacted at the coal face of health planning at provincial and district level.

HIV Aids Communication Strategy

Our responsibility was to create an appropriate communication strategy to the public while ensuring the accuracy of the clinical information and debunk any myths surrounding the disease. This involved the ABC Campaign, PMTCT (then) and key points to where communities and individuals can seek help to prevent the spread of HIV Alds. We created the communication strategy in the common languages of the affected communities, used cultural symbols and norms to promote safe behavioral patterns and alter attitudes. We conceived and commissioned the Aids Song through an Idol format (talent search competition) with lyrics which had a positive message for HIV Aids and make it integrated to popular culture

Department of Transport

To support Arrive Alive Campaign by the Department of Transport, We were tasked to design an end to end program that would support victims of road accidents. We designed a victim and dependent support program based on Best practice model adopted in advanced jurisdictions such as Victoria State, Australia. By providing Trauma Counselling, ongoing PTSD linking the survivors and dependents to the Road Accident Fund platform for their claims and benefits we targeted accidents involving (7 or more deaths) road and train accidents. For the period when the program was running we assisted more than 300 people.

Commercial Real Estate

I have held some consulting assignments for the for Retail Sector to optimize Mall utilization and surrounding infrastructure. I advised on commercial property portfolio optimization, acquired and provided facilities management to the Chamber House. I served as a member of the KZN South African Property Owner's Association, as well as consulted to the KZN Department of Public Works on Youth in Property Program. :
