Elle est légèrement supérieure chez les femmes (1,0%) que chez les hommes (0,3%). La prévalence de l'usage quotidien du tabac sans fumée est de 0,6% et celle de l'usage occasionnel est de 0,1%. Autant de femmes (0,9%) que d'hommes (0,3%) utilisent le tabac sans fumée sur une base quotidienne. Depuis 2018, nous avons noté la recrudescence d'un nouveau type de tabac dénommé chicha ou narguilé qui est utilisé par la population et notamment les jeunes et dont la consommation est plus dangereuse que le tabac à fumée.</p>
