Esto se logra gracias a la aplicación del “Programa de prevención del consumo de drogas en la población estudiantil” que el Ministerio de Educación realiza en convenio interinstitucional con la Comisión Nacional para el Desarrollo y Vida sin Drogas. El programa incluye una propuesta pedagógica en la que se aborda la prevención de todo tipo de drogas legales e ilegales, entre ellas, el consumo del tabaco. En ese sentido se ha logrado:</p> <ul style="list-style-type: none"> <li>- Fortalecer factores protectores de riesgo relacionados al consumo de tabaco y otras drogas, en estudiantes de instituciones educativas de educación secundaria.</li> <li>- Fortalecer las capacidades parentales de las familias para el acompañamiento de sus hijos frente al peligro del consumo de drogas legales e ilegales.</li> <li>-Fortalecer capacidades de las y los docentes de las instituciones educativas focalizados para el abordaje de la prevención del consumo de drogas legales e ilegales.</li> </ul> <p>Por otro lado, en el marco del Currículo Nacional de Educación Básica, aprobado por Resolución Ministerial N° 281-2016-MINEDU, se desarrollan actividades pedagógicas para el logro de aprendizajes relacionados cuidado de la salud, que incluye entre otros, la prevención del uso de sustancias nocivas para la salud como el tabaco. Asimismo, la Resolución Viceministerial N° 212-2020-MINEDU que aprueba los Lineamientos de Tutoría y Orientación Educativa para la Educación Básica, tiene como líneas de acción a la prevención para anticipar o reducir la aparición de situaciones o conductas de riesgo que pongan en peligro el desarrollo integral y el bienestar de los estudiantes. Para ello, se cuenta con dos horas de trabajo semanal en el horario escolar, en las que se desarrollan sesiones de aprendizaje de tutoría en las que se abordan diversas temáticas, incluidas la prevención del consumo de drogas. Se han incluido en los programas al público en general, especialmente en los dos últimos años, contenidos de difusión relacionados a aspectos económicos e impactos medioambientales de la producción y consumo de tabaco. Como parte de las acciones interinstitucionales, existe el compromiso del MINAM para incorporar una actividad vinculada con el 31 de mayo, “Día Mundial sin Tabaco”, como parte de las fechas conmemorativas del Calendario Ambiental Peruano (CAP). El CAP es un listado de fechas conmemorativas vinculadas con el cuidado y la protección del ambiente que cada año el MINAM prioriza para que las diferentes entidades públicas y privadas del país las tomen en cuenta y promuevan acciones de educación ambiental dirigidas a los diferentes usuarios: gestores ambientales, docentes, estudiantes, ciudadanía en general. La actividad sugerida para la fecha indicada, sería coordinada con el MINSa, a efectos de llamar la atención sobre el impacto de la producción y el consumo del tabaco en la salud humana y el ambiente.
