B115		Please provide a brief explanation of the trend in smoking prevalence in the adult population in the past two years or since submission of your last report. Los datos aportados por la Oficina de Prevención del Consumo de Tabaco son los publicados en la Encuesta Nacional de Salud 2016-2017, del Ministerio de Salud de Chile. y corresponden al capítulo- Consumo de Tabaco. En base a los estudio de Prevalencia Consumo de Tabaco en Población General elaborados por el Servicio Nacional para la Prevención y Rehabilitación del Consumo de Drogas y alcohol. (SENDA 2020) Los resultados de este estudio, reportan una estabilización en la baja de la prevalencia del consumo de tabaco de las mediciones de los estudios anteriores, por cuanto las declaraciones sobre uso diario de tabaco permanecieron estables respecto al lapso de tiempo comprendido entre los años 2014 y 2018 (22,7% en 2014 a 21,2% en 2016, 19,6% en 2018 y 19% en 2020). Al desagregar por sexo, no se observan variaciones significativas respecto al estudio anterior;(SENDA, 2018) . La brecha observada entre ambos no es estadísticamente significativa en 2020 (H 19,5% frente a M 20,1%). La desagregación por nivel socioeconómico (NSE) muestra que la prevalencia de “consumo diario” de tabaco en NSE Bajo (21,3%) es significativamente mayor que la reportada en NSE Medio (20,3%) y NSE Alto (17%). No se registran variaciones estadísticamente significativas respecto a 2016 por nivel socioeconómico.

Estableciendo que en el grupo de 20 a 29 años se observa diferencia estadísticamente significativa de la ENS 2016-2017 y ENS 2009-2010. En los grupos de 15 a19 años y el grupo de 65 años y más se observa diferencias estadísticamente significativa en relación al resto de grupos de edad.
