# FCTC

“tobacco products” means products entirely or partly made of the leaf tobacco as raw material which are manufactured to be used for smoking, sucking, chewing or snuffing;

*Seriously concerned* about the increase in the worldwide consumption and production of cigarettes and other tobacco products, particularly in developing countries, as well as about the burden this places on families, on the poor, and on national health systems,

*Recognizing also* that cigarettes and some other products containing tobacco are highly engineered so as to create and maintain dependence, and that many of the compounds they contain and the smoke they produce are pharmacologically active, toxic, mutagenic and carcinogenic, and that tobacco dependence is separately classified as a disorder in major international classifications of diseases,

*Alarmed* by the increase in smoking and other forms of tobacco consumption by women and young girls worldwide and keeping in mind the need for full participation of women at all levels of policy-making and implementation and the need for gender-specific tobacco control strategies,

# FCTC COP 7

## Control and prevention of waterpipe tobacco products

Parties to comply with article 5.3 and its guidelines in relation to waterpipe tobacco policies and control




# Brief overview on 5.3

In setting and implementing their public health policies with respect to tobacco control, Parties shall act to **protect** these **policies** from commercial and other vested interests of the tobacco **industry** in accordance with national law.



# 4 Principles

- A fundamental conflict of interest
- Parties should be accountable and transparent
- Parties should require the tobacco industry to be accountable and transparent
- The tobacco industry should not be granted incentives to establish or run their businesses



# 8 recommendations (1-2)

- Raise awareness about tobacco products and about tobacco industry interference
- Establish measures to limit interactions with the tobacco industry
- Reject partnerships and non-binding or non-enforceable agreements with the tobacco industry
- Avoid conflicts of interest for government officials and employees



# 8 recommendations (2-2)

- Require that information provided by the tobacco industry be transparent and accurate
- De-normalize and regulate activities described as “socially responsible” by the tobacco industry, including but not limited to corporate social responsibility
- Do not give preferential treatment to the tobacco industry
- Treat State-owned tobacco industry in the same way as any other tobacco industry



# Brief overview on waterpipe smoking in EM

## Public believes

Available evidence shows that waterpipe tobacco users perceive it as *less harmful* and *less addictive* than cigarettes.

In one of our countries, *57% of adults* believe that waterpipe tobacco is less harmful



# Unfortunately, it is trending



# Prevalence

- EM region has the highest prevalence of waterpipe use in the world <sup>1</sup>
- Usage is increasing among young people <sup>1</sup>
- Mean prevalence estimates <sup>2</sup>:

<b>Adults</b>	<b>31.9</b>
<b>Youth</b>	<b>28.6</b>

The waterpipe tobacco epidemic has become worse with the growing list of flavourants and additives which have made waterpipe use more attractive to youth.


This growth has also attracted the **multinational tobacco industry**, which is now investing in producing and marketing waterpipe tobacco.\*

Professor Roger Scruton, darling of the moral right, asked one of the world's biggest tobacco companies for £5,500 a month to help place pro-smoking articles in some of Britain's most influential newspapers and magazines.

The controversial conservative academic offered to use his Fleet Street contacts to get pieces published in his own name and those of others on "major topics of current concern" to the tobacco industry.

In a leaked email to Japan Tobacco International seeking a £1,000 rise on his existing £4,500 monthly fee, Prof Scruton argued that in a business "largely conducted by shysters and sharks" he represented value for money.

"We would aim to place an article every two months in one or other of the WSJ [Wall Street Journal], the Times, the Telegraph, the Spectator, the Financial Times, the Economist, the Independent or the New Statesman," says the note, sent last October under the name of Sophie, his wife and


