



# Lesotho STEPS Survey 2012

## Fact Sheet

The STEPS survey of chronic disease risk factors in Lesotho was carried out from April to May 2012. Lesotho carried out Step 1, Step 2 and Step 3. Socio demographic and behavioural information was collected in Step 1. Physical measurements such as height, weight and blood pressure were collected in Step 2. Biochemical measurements were collected to assess blood glucose and cholesterol levels in Step 3. The STEPS survey in Lesotho was a population-based survey of adults aged 25-64. A multi-stage cluster sample design was used to produce representative data for that age range in Lesotho. A total of 2310 adults participated in the survey. The overall response rate was 80%.
