



Botswana STEPS Survey 2007

Fact Sheet

The STEPS survey of chronic disease risk factors in Botswana was carried out from March 2007 to August 2007. Botswana carried out Step 1 and Step 2. Socio demographic and behavioural information was collected in Step 1. Physical measurements such as height, weight and blood pressure were collected in Step 2. The STEPS survey in Botswana was a population-based survey of adults aged 25-64. A Multi-stage cluster sample design was used to produce representative data for that age range in Botswana. A total of 4,003 adults participated in the Botswana STEPS survey.
