



# Seychelles STEPS Survey 2004

## Fact Sheet

The STEPS survey of chronic disease risk factors in Seychelles was carried out from April to September, 2004. Seychelles carried out Step 1, Step 2 and Step 3. Socio demographic and behavioural information was collected in Step 1. Physical measurements such as height, weight and blood pressure were collected in Step 2. Biochemical measurements were collected to assess blood glucose levels in Step 3. The STEPS survey in Seychelles was a population-based survey of adults aged 25-64. A sex- and age- stratified random sample design was used to produce representative data for that age range Seychelles. A total of 1,255 adults participated in the Seychelles STEPS survey. The overall response rate was 80.3%.
