



Benin (Cotonou) STEPS Survey 2007

Fact Sheet

The STEPS survey of chronic disease risk factors in Benin (Cotonou) was carried out from August 2007 to September 2007. Benin (Cotonou) carried out Step 1, Step 2 and Step 3. Socio demographic and behavioural information was collected in Step 1. Physical measurements such as height, weight and blood pressure were collected in Step 2. Biochemical measurements were collected to assess blood glucose levels in Step 3. The STEPS survey in Benin (Cotonou) was a population-based survey of adults aged 25-64. A cluster sample design was used to produce representative data for that age range in Benin (Cotonou). A total of 2,568 adults participated in the Benin (Cotonou) STEPS survey. A repeat national survey is planned for 2008 if funds permit.
