


GYTS Objectives

The Global Youth Tobacco Survey (GYTS), a component of the Global Tobacco Surveillance System (GTSS), is a global standard for systematically monitoring youth tobacco use (smoking and smokeless) and tracking key tobacco control indicators.


GYTS is a cross-sectional, nationally representative school-based survey of students in grades associated with ages 13 to 15 years. GYTS uses a standard core questionnaire, sample design, and data collection protocol. It assists countries in fulfilling their obligations under the World Health Organization (WHO) Framework Convention on Tobacco Control (FCTC) to generate comparable data within and across countries. WHO has developed MPOWER, a technical package of selected demand reduction measures contained in the WHO FCTC:



GYTS Methodology

GYTS uses a global standardized methodology that includes a two-stage sample design with schools selected with a probability proportional to enrollment size. The classes within selected schools are chosen randomly and all students in selected classes are eligible to participate in the survey. The survey uses a standard core questionnaire with a set of optional questions that countries can adapt to measure and track key tobacco control indicators. The questionnaire covers the following topics: tobacco use (smoking and smokeless), cessation, secondhand smoke (SHS), pro- and anti-tobacco media and advertising, access to and availability of tobacco products, and knowledge and attitudes regarding tobacco use. The questionnaire is self-administered; using scannable paper-based bubble sheets, it is anonymous to ensure confidentiality.

In Tuvalu, GYTS was conducted as a census in 2018 by the Ministry of Health. The overall response rate was 89.9%. A total of 764 eligible students in classes 6-8 and forms 3-6 completed the survey, of which 424 were aged 13-15 years. Data are reported for students aged 13-15 years.



GYTS Highlights

TOBACCO USE

- 21.2% of students, 30.4% of boys, and 13.6% of girls currently used any tobacco products.
- 19.8% of students, 30.4% of boys, and 11.2% of girls currently smoked tobacco.
- 17.5% of students, 28.5% of boys, and 8.0% of girls currently smoked cigarettes.
- 29.2% of students, 36.7% of boys, and 23.1% of girls ever smoked cigarettes.

CESSATION

- Almost 7 in 10 (67.3%) current tobacco smokers tried to stop smoking in the past 12 months.
- Almost 9 in 10 (87.2%) current tobacco smokers wanted to stop smoking now.

SECONDHAND SMOKE

- 43.4% of students were exposed to tobacco smoke at home.
- 28.9% of students were exposed to tobacco smoke inside enclosed public places.

ACCESS & AVAILABILITY

- 39.6% of current cigarette smokers bought cigarettes from a store or street vendor.
- Among current cigarette smokers who tried to buy cigarettes, 12.6% were not prevented from buying them because of their age.

MEDIA


- More than 8 in 10 (82.2%) students noticed anti-tobacco messages in the media.
- More than 7 in 10 (74.1%) students noticed anti-tobacco at sporting or community events.
- More than 6 in 10 (62.2%) students were taught in school about the dangers of tobacco in the past 12 months.
- More than 8 in 10 (82.6%) students saw anyone using tobacco on television, videos, or movies.

KNOWLEDGE & ATTITUDES

- 55.9% of students definitely thought other people's tobacco smoking is harmful to them.
- 79.9% of students favored prohibiting smoking at outdoor public places.

NOTE: Data are nationally representative of all students aged 13-15 years who are enrolled in school. A census was done of all schools containing students in classes 6-8 and forms 3-6, and all students within all schools were surveyed. Percentages reflect the prevalence of each indicator in each group, not the distribution across groups.
