An Act to amend the Excise Act [CAP 290].

Be it enacted by the President and Parliament as follows-

#### 1 Amendment

The Excise Act [CAP 290] is amended as set out in the Schedule.

#### 2 Commencement

This Act commences on 1 January 2015.
