
















# **UNICEF procurement guiding principles**

Purchases primarily from manufacturers and authorised representatives

Evaluates and registers suppliers with which it does business

Uses competitive tendering for all procurement (procurement policies)

Invites an appropriate geographical range of suppliers to tender


Purchases products that comply with recognised technical standards

**Does not** purchase from companies employing <u>child labour</u>, nor manufacturers of <u>land mines</u> and their components (Supplier Code of Conduct)

**Does not** purchase from companies found to have undertaken unethical, unprofessional or fraudulent activities (**clause 7 of UNICEF's GTCs on ethical standards**)







- In 2022 UNICEF procured \$7.383 billion worth of supplies and services representing a 3 per cent increase from 2021 levels and a 93 per cent increase from 2019 (pre-pandemic) levels.
- The 2022 levels were driven by the response to new and ongoing emergencies, the Food Insecurity Crisis, and continued demand for construction services



## **TOP COMMODITY GROUPS 2022**

### \$3.736 billion Vaccines/biologicals

- 3.429 billion doses of vaccines for 108 countries.
- COVAX delivered 924.6 million doses of COVID-19 vaccine to 113 countries.
- UNICEF managed the delivery of more than 977.9 million COVID-19 vaccines to 92 countries.

### \$322.1 million

### Medical supplies and equipment

- includes \$321 million PPE items to 121 countries.
- UNICEF delivered 2.4 billion syringes for immunization and 22.1 million safety boxes.



### **\$164.6 million Cold chain equipment**

 \$84.6 million in solar-powered systems procured for 63 countries.

### \$392.4 million Nutrition

- 68,702 metric tons of RUTF delivered to 64 countries.
- A 90 per cent increase from 2021

### \$134.3 million Education

 162,830 education kits procured for 52 countries.

### \$188.7 million Water and sanitation

 2.191 billion purification tablets and sachets to treat 62 billion litres of water.



### \$149 million **Pharmaceuticals**

- 221 million amoxicillin pneumonia tablets for children under 5 years old in 41 countries.
- 88.6 million cotrimoxazole tablets to 21 countries.
- 24.2 million ACT malaria treatments to 25 countries.

### \$81.5 million Bed nets/insecticides

 18.6 million LLINs were delivered to 21 countries.

## **2022 Key Results**


### Ready-to-Use Therapeutic Food (RUTF): 5 million cartons (68,702 MT) delivered to 64 countries

Multiple micronutrient powder: 612.7 million sachets delivered to 42 countries

Iron-folic acid (IFA): 482 million tablets delivered to 40 countries

Multiple Micronutrient Supplement (MMS): 82 million tablets delivered to 45 countries

Vitamin A: 475.9 million capsules delivered to 71 countries



#### Amox DT: 221 million dispersible

tabs equivalent to 22 million pneumonia treatments delivered to 41 countries

**ORS: 47 million sachets** 

including 11.3 sachets copackaged with zinc delivered to 23 countries

**ARVs: 1.60 million packs** delivered to 34 countries – enough to provide 27,601 adults and 70,558 children with one year of first-line therapy

Cotrimoxazole: 88.8 million tablets delivered to 21 countries

Artemisinin-based Combination Therapy (ACT): 24.2 million malaria treatments delivered to 25 countries

**De-worming tabs:** 101 million tablets delivered to 49 countries



## **Focus areas for Medicines and Nutrition**

Procurement focus that addresses UNICEF programmatic priorities

Follow and promote **WHO recommendations** on selection and use of medicines and international guidelines on nutrition

Ensure availability of **affordable** essential medicines and nutrition supplies for primary health care and emergency relief


Develop **sources and market** for priority products

Ensure capacity to excel in **procurement activities** (quality assurance, selection, contracting, supply chain management)

Make a measurable contribution to the achievement of the SDGs through **sustainable procurement.** 



### ACCESS TO MEDICINES UNICEF MEDICINES PRODUCT PORTFOLIO BASED ON WHO MODEL EML




#### Legend

## **Medicine Procurement**




139 Suppliers in 36 countries, have been used to procure 377 standard UNICEF medicines presentations, which represent 95% of the procurement.

Medicines delivered to 90 countries

- Amoxicillin dispersible tablets and other betalactams
- Antimalarials
- Vitamin A
- Iron folic acid (IFA)
- Multiple micronutrient tablets (MMS)
- ORS and Zinc
- Large volume parenterals
- Deworming tablets

40-50% of medicines are procured for delivery to Supply Division Warehouse in Copenhagen


