Thank you for your submission that was received on 4 April 2022 and accepted for assessment on 23 May 2022 expressing Fujian Yamei Industry & Trade Co. Ltd.'s interest to participate in the procedures for prequalification of vector control products. The review of your company's product dossier for:

has been completed and it has been found to meet the norms and standards recommended by the World Health Organization (WHO) for insecticide treated net (ITN) products and is acceptable, in principle, for procurement by the United Nations (UN) and other international agencies and countries.

This conclusion is based on information available to WHO at the current time, i.e., the information in the submitted dossier and on the status of ISO 9001 Certification at the facilities used for the manufacture of the product. The applicants and the manufacturers of prequalified products are required to communicate to WHO details of any changes in manufacture or control that may have an impact on the safety, efficacy and/or quality of the product.

Finally, I should like to draw your attention to the fact that the list will be reviewed and updated at regular intervals. Consequently, WHO will, at regular intervals, arrange for the products and manufacturing sites included in the list to be re-evaluated. If, as a result of this reassessment, it is found that a product and/or specified manufacturing site no longer complies with the WHO recommended standards, such products will be removed from the list. The failure of an applicant or a manufacturer to participate in the reassessment procedure will also lead to removal from the list.
