BACKGROUND INFORMATION ON THE PROCEDURE

1. Submission of the dossier

The company Cipla Ltd submitted in 2014 an application for [HA628 trade name] ¹ (HA628) to be assessed with the aim of including [HA628 trade name] in the list of prequalified medicinal products for the treatment of HIV/AIDS.
