WHO PUBLIC ASSESSMENT REPORT (WHOPAR)

[MA121 trade name]*

Artemether/lumefantrine 60 mg/360 mg tablets

[MA121 trade name], manufactured at Cipla limited, Tehsil Nalagarh, District Solan, Himachal Pradesh, India, was included in the WHO list of prequalified medicinal products for the treatment of malaria on 17 July 2017.

[MA121 trade name] is indicated for the treatment of uncomplicated malaria due to *Plasmodium falciparum* in children weighing 25 to less than 35 kg. Detailed information on the use of this product is described in the summary of product characteristics (SmPC), which can be found in this WHOPAR.

The active pharmaceutical ingredients (APIs) of [MA121 trade name] are the artemisinin derivative artemether and lumefantrine.

The efficacy and safety of artemether and lumefantrine are well established based on extensive clinical experience in the treatment of malaria.

For details on the uses of this product and for side effects and warnings, see Part 4 of this WHOPAR (summary of product characteristics).

On the basis of data submitted and public information on the use of artemether/lumefantrine in malaria, the team of assessors advised that [MA121 trade name] is of acceptable quality, efficacy and safety to allow inclusion of [MA121 trade name] in the list of prequalified medicinal products.
