**WHO PUBLIC ASSESSMENT REPORT (WHOPAR)**

Levofloxacin 500 mg tablets

[TB238 trade name], manufactured at Micro Labs Limited, Hosur, Tamil Nadu, India, was included in the WHO list of prequalified medicinal products for the treatment of tuberculosis on 03 October 2012.

[TB238 trade name] is indicated in combination with other tuberculosis medicines for the treatment of drug-resistant tuberculosis due to *Mycobacterium tuberculosis*. It is also indicated as monotherapy for the prevention of multidrug-resistant tuberculosis in persons at risk. Detailed information on the use of this product is described in the summary of product characteristics (SmPC), which can be found in this WHOPAR.

The active pharmaceutical ingredient of [TB238 trade name] is levofloxacin.

The efficacy and safety of levofloxacin are well established based on extensive clinical experience in the treatment of tuberculosis.

For details on the uses of this product and for side effects and warnings, see Part 4 of this WHOPAR (summary of product characteristics).

On the basis of data submitted and public information on the use of levofloxacin in tuberculosis, the team of assessors advised that [TB238 trade name] is of acceptable quality, efficacy and safety to allow inclusion of [TB238 trade name] in the list of prequalified medicinal products.
