

WHO Prequalification Programme WHO PUBLIC ASSESSMENT REPORT (WHOPAR)

[TB406 trade name] *

Ethambutol hydrochloride 100 mg dispersible tablets

[TB406 trade name], manufactured at Cadila Pharmaceuticals Limited, Ahmedabad, Gujarat, India, was included in the WHO list of prequalified medicinal products for the treatment of tuberculosis on 21 November 2024.

[TB406 trade name] is currently indicated in combination with other tuberculosis medicines for the treatment of tuberculosis due to *Mycobacterium tuberculosis* including in regimens for drug-resistant tuberculosis. Detailed information on the use of this product is described in the summary of product characteristics (SmPC), which can be found in this WHOPAR.

The active pharmaceutical ingredient of [TB406 trade name] is ethambutol hydrochloride.

The efficacy and safety of ethambutol hydrochloride are well established based on extensive clinical experience in the treatment of tuberculosis.

On the basis of data submitted and public information on the use of ethambutol, the team of assessors advised that [TB406 trade name] is of acceptable quality, efficacy and safety to allow inclusion of [TB406 trade name] in the list of prequalified medicinal products.
