As of the 25 August 2022, 184 countries (94%) provided WHO with the SPAR Report for 2021, the highest submissions so far for a SPAR reporting cycle. The IHR Monitoring and Evaluation Framework outlines the various mechanisms for monitoring capacities required under the IHR and underscores the mutual accountability, transparency, experience sharing and dialogue between Member States and WHO which contributes to global health security. # B. TRIPARTITE OPERATIONAL TOOLS: JOINT RISK ASSESSMENT; MULTISECTORAL, ONE HEALTH, COORDINATION MECHANISM; SURVEILLANCE AND INFORMATION SHARING

In 2019, the Tripartite (FAO, OIE and WHO), launched the Tripartite Zoonoses Guide (TZG) to provide guidance and best practices for addressing zoonotic diseases in countries. Three operational tools are available (or in development) and can be used independently or in coordinated efforts to support national capacity for zoonotic disease preparedness and response. The Joint Risk Assessment (JRA OT) is published and available for national workshops. Two additional tools are in development and include the Multisectoral, One Health, Coordination Mechanism (MCM OT) and Surveillance and Information Sharing (SIS OT). #### **RISK PROFILING**

Strategic Risk Assessments are undertaken before an event occurs. A strategic risk assessment is used to guide risk-informed programming that will catalyse action to prevent, prepare for, and reduce the level of risk associated with a particular hazard and its consequences on health. Actions that stem from a strategic risk assessment can include the prioritisation of limited resources, in-depth capacity and vulnerability assessments, development of emergency response and contingency plans, and the implementation of preparedness and risk mitigation activities.

The WHO Strategic Toolkit for Assessing Risks (STAR) has been published and is available at the following link https://www.who.int/publications/i/item/9789240036086.

The STAR toolkit supports countries in identifying all-hazard preparedness and disaster risks. STAR also facilitates the development of robust policies, strategies and plans to address the vulnerabilities that countries can face in terms of health emergencies and disasters.
