CURRENT PRIORITIES

Vision 2030 set by the Government prioritizes the health sector as a significant contributor to the wellbeing of the people of Zambia. The Government is committed to the provision of quality health services and continued investment in the health sector since a healthy population is critical to improved production and productivity. Since 2010, progress has been recorded in most of the key areas of health service delivery and health support systems. Despite these achievements, the health sector still faces challenges. The NHSP 2011-2016 includes collaborating with relevant stakeholders to speed up the implementation of the National Decentralization Policy, in order to facilitate improved service delivery.

LINKAGE TO UHC

Access by the population to quality social and health services has been an area of concern for successful Zambian Governance since independence in 1964. Moreover, the concept of *"equity of access to assure quality, cost-effective and affordable health services, as close to the family as possible"* is at the heart of the 1992 National Health Policies and Strategies which is guiding policy reforms since its enactment. Public health infrastructures have been progressively brought closer to the population, while decentralization policies were aimed at giving them ownership on their health services. Different health financing systems have been tested, resulting today in an increasing tendency towards the provision of free or highly subsidized health services. Today, the National Health Policy explicitly spells out ways for advancing UHC, and UHC is part of the broader national efforts to deal with extreme poverty, social exclusion and gender inequity. However, with at least 68% of the population living in poverty, access to health services is still compromised in terms of access and affordability.

First steps into the Partnership : the use of a tailored roadmap supporting the current needs of Zambia



The Republic of Zambia is one of the countries newly joining the UHC Partnership in Phase III. Once a country gains membership in the UHC Partnership, an inception mission is organized by WHO staff. During this mission, the Zambia Ministry of Health (MOH) convened - with WHO support - key health stakeholders to align on a country road map with activities which support the current needs of the country in areas linked to policy dialogue on national plans, health financing and/or effective development cooperation. In drawing up the country-specific roadmap, particular attention was paid not only to input and output, but also to outcome indicators. The activities included in the roadmap will guide the implementation and expenditures decisions over the two years period of the UHC Partnership with the MoH Zambia.
